Declaration of Restrictive Covenants and Restrictions, Agreements, Restrictions, Covenants and Conditions affecting the official plan thereof, executed by CHADAZ L.C., a Utah Limited Liability Company and Continental Construction Inc. a Corporation. (hereinafter referred to as "Declarant")

WITNESSETH:

WHEREAS, "Declarant" is the owner of certain real property, located in Tremonton City, Box Elder County, Utah, upon which Chadaz Estates Phase I Subdivision is located which includes lots one through thirty five. Declarant hereby amends Section four #D as follows:

D. Size: The ground floor area of the main structure, (rambler) one-story not including open porches and garages, shall be not less than, one thousand (1000) square ft. Two (2), Three (3) and four (4) level homes must have not less than eleven hundred (1100) square feet finishd. This can be achieved by counting the upper two (2) levels and one half (1/2) of the third level. A double two (2) car garage either be attached or detached with not less than four hundred (400) square feet is optional. Any auxilliary buildings must be so designed and constructed as to be compatible in appearance with the main building and meet all Tremonton City Ordinances.

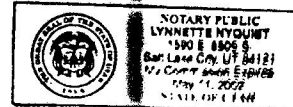

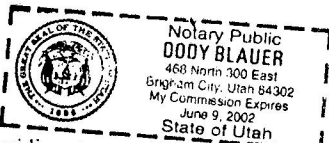
