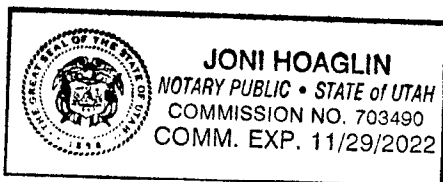

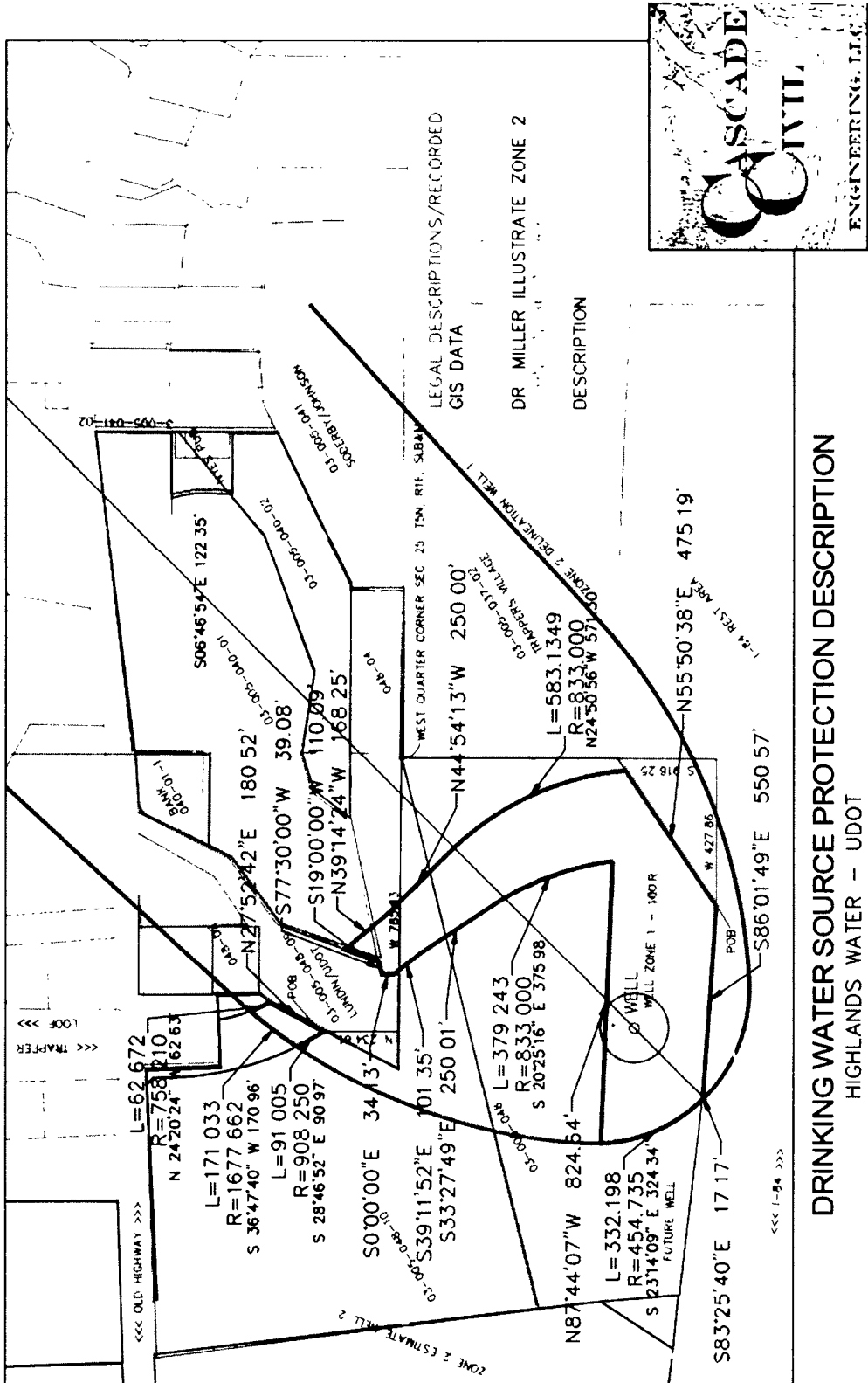

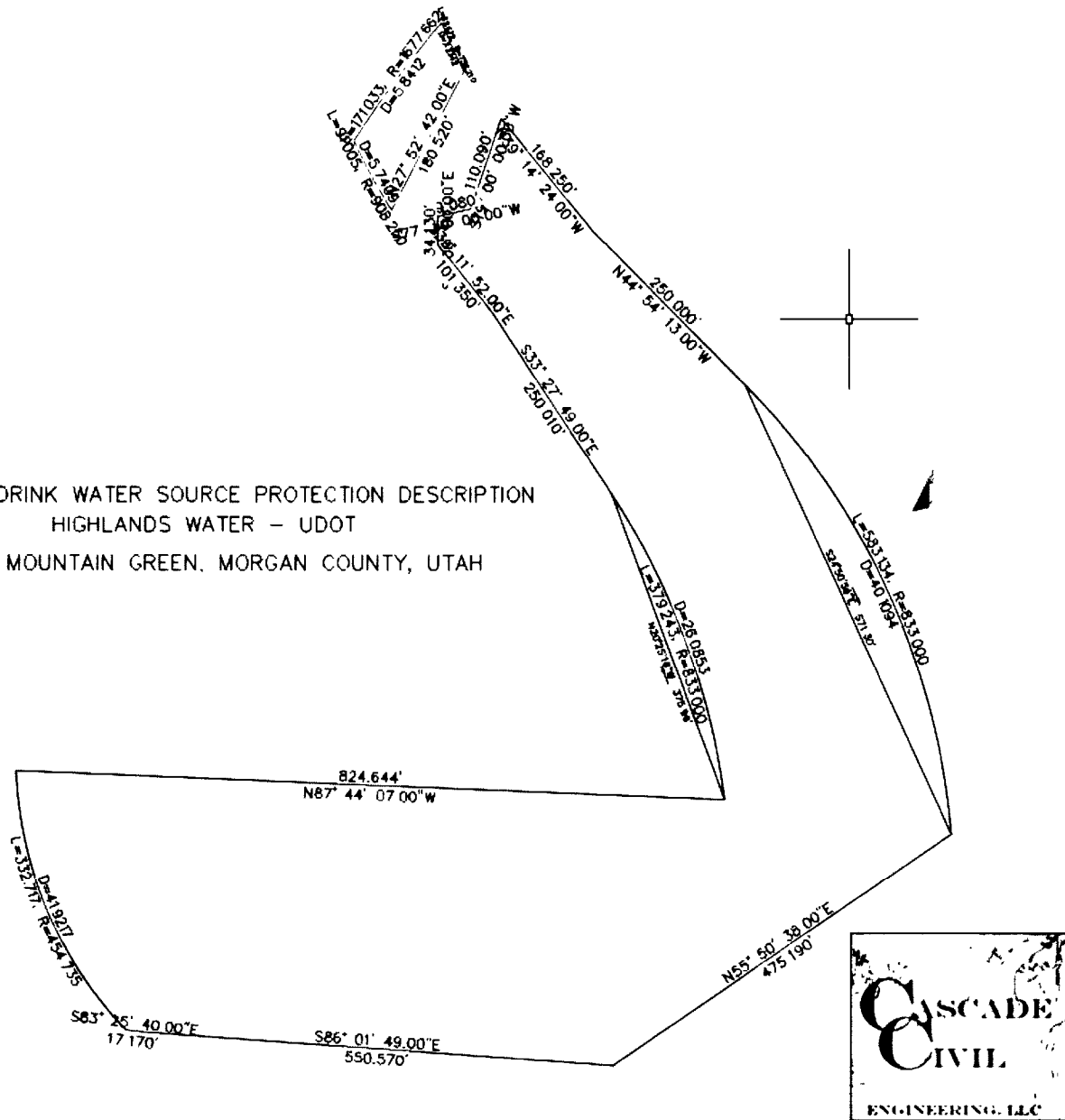

Land Use Agreement

For Zone One and Zone Two for the Johnson Well #1

UDOT Project No. S-0167(7)2
UDOT Parcel No. 0167:101:A

The Utah Department of Transportation ("UDOT"), the undersigned landowner, acknowledges the Drinking Water Source Protection Plan for the Johnson Well #1 as shown in Exhibit A. UDOT agrees not to locate or allow the location of any uncontrolled potential contamination sources, as defined in R309-600-6(1)(w) of the Utah Administrative Code, within Zone One. We also agree not to locate or allow the location of any pollution sources, as defined in R309-600-6(1)(v) of the Utah Administrative Code, within Zone Two unless design standards are implemented to prevent contaminated discharges. This agreement is binding on all heirs, successors, and assigns.

This Land Use Agreement applies to UDOT Parcel 0167:101:A as described in Exhibit B. The well location being 2,022.47 feet North and 785.04 feet west from the Southwest Corner of Section 25, Township 5 North, Range 1 East, Salt Lake Base and Meridian on the subject parcel.
