

REMAINDER DESCRIPTION FROM BOOK "Q" PAGE 361: A PART OF LOTS 1 AND 2 OF SECTION 27, TOWNSHIP 4 NORTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN. BEGINNING AT A POINT ON THE NORTH BOUNDARY OF THE UNION PACIFIC RAILROAD RIGHT OF WAY AND IS SOUTH 88°26' WEST 1690 FEET AND SOUTH 58°15' EAST 1020 FEET FROM THE NORTHEAST CORNER STONE OF SAID SECTION 27; AND RUNNING THENCE SOUTHWESTERLY 792 FEET, MORE OR LESS, ALONG SAID NORTH BOUNDARY OF UNION PACIFIC RAILROAD RIGHT OF WAY TO THE EAST LINE OF THE STATE ROAD COMMISSION PROPERTY; THENCE ALONG SAID EAST LINE 11 COURSES AS FOLLOWS: NORTH 14°10' EAST 222 FEET TO A POINT ON A 2904.79 FOOT RADIUS CURVE TO THE LEFT; THENCE 253.5 FEET ALONG THE ARC OF SAID CURVE TO THE POINT OF TANGENCY; THENCE NORTH 09°10' EAST 11 FEET TO A POINT ON A 160 FOOT RADIUS CURVE TO THE LEFT; THENCE 217 FEET ALONG THE ARC OF SAID CURVE TO THE POINT OF TANGENCY; THENCE NORTH 09°10' EAST 72.35 FEET TO THE POINT OF CURVATURE OF A 512.96 FOOT RADIUS CURVE TO THE RIGHT; THENCE 143.8 FEET ALONG THE ARC OF SAID CURVE TO THE POINT OF TANGENCY; THENCE NORTH 25°13' EAST 107 FEET; THENCE SOUTH 68°20' EAST 100 FEET TO A POINT ON A 190 FOOT RADIUS CURVE TO THE RIGHT (NOTE: TANGENT TO SAID CURVE BEARS NORTH 21°40' EAST); THENCE NORTHEASTERLY 126 FEET ALONG THE ARC OF SAID CURVE TO THE POINT OF TANGENCY; THENCE NORTH 59°40' EAST 53.20 FEET AND THENCE NORTH 73°48' EAST 95 FEET; THENCE LEAVING SAID STATE ROAD COMMISSION PROPERTY AND RUNNING SOUTH 58°15' EAST 289 FEET TO THE POINT OF BEGINNING.
