## NOTICE OF RESCISSION OF THE DECLARATION OF EASEMENTS, COVENANTS, CONDITIONS AND RESTRICTIONS FOR SLEEPY RIDGE

## RECITALS

- A. This Notice of Rescission of the Declaration of Easements, Covenants, Conditions and Restrictions for Sleepy Ridge ("Notice of Rescission") affects the real property situated in Utah County, described with particularity on Exhibit A ("Subject Property"), which exhibit is attached hereto and incorporated by reference.
