AMENDMENT TO RESTRICTIONS

KNOW ALL MEN BY THESE PRESENTS:

Whereas the undersigned K. P. ALEXANDER and PAUL F. POTTER, are designated as a committee to serve for the first three years following September 1, 1954 as the governing body of the owners of property in MOUNT OLYMPUS ACRES ADDITION #4, according to the official plat thereof on file and of record in the office of the County Recorder of Salt Lake County Utah, all as set forth and provided in those certain restrictive covenants dated September 1, 1954 and recorded September 1, 1954 in Book 1120 at Page 610 as Entry No. 1388121 of the records of the Salt Lake County Recorder, and ,

Whereas since the execution and recordation of said restrictive covenants the property owners have organized and there is presently existing an association of the owners known as the MOUNT OLYMPUS ACRES ASSOCIATION, and it is the desire and intention of the owners of property involved that said association, shall be substituted for the undersigned as the committee referred to in said restrictive covenants;

NOW THEREFORE, the undersigned hereby certify and declare that the MOUNT OLYMPUS ACRES ASSOCIATION, shall be and is hereby constituted the committee with full power and authority to act as provided in said restrictive covenants and particularly as set forth in paragraphs designated "D" and "E" thereof, said association to act in the place of and in substitution for the undersigned as aforesaid.

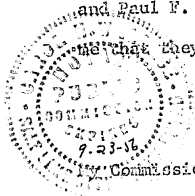
