

Resolution No. 97-01

**A RESOLUTION OF WEBER COUNTY SERVICE AREA NUMBER 4 PROVIDING
THAT FARR WEST CITY BE ANNEXED INTO THE SERVICE AREA AND THAT
DISTRICT FIRE SERVICES BE PROVIDED TO FARR WEST CITY, AND
PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the Weber County service area number 4 (HEREINAFTER "FIRE DISTRICT" OR "DISTRICT"), by virtue of the provisions of UCA § 17A-2-412, is a body corporate and politic and a quasi-municipal public corporation duly organized and existing under the laws of the State of Utah; and,

WHEREAS, in conformance with the provisions of UCA § 17A-2-411 the Board of Trustees of the district (herein called the "Board of Trustees") may exercise all legislative and administrative powers by ordinance and resolution; and,

WHEREAS, UCA § 17A-2-417 provides, in relevant part, that whenever the services of the type being provided within a county service area should be provided in an incorporated portion of the county, the Board of Trustees may annex that territory to the district, and,

WHEREAS, annexation by the Board of Trustees is governed by the procedures established in UCA § 17A-2-417 and other relevant state legislation; and,

WHEREAS, the Board of Trustees may not pursue procedures to annex territory located within a municipality unless the municipality's legislative body first adopts and presents to the Board of Trustees a petition requesting annexation; and,

WHEREAS, the governing body of Farr West City has presented a petition and resolution to the Board of Trustees of the district requesting that Farr West City be annexed into the district; and,

WHEREAS, the Board of Trustees finds that the public convenience and necessity, and safety, requires the annexation of Farr West into the district;

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Weber Fire District, in conformance with the applicable provisions of state law, that the petition of the city council of Farr West City be acknowledged and received together with their request for annexation into the district; and,

BE IT FURTHER RESOLVED that in accordance with the requirements of UCA § 17A-2-406, the boundaries of the territory proposed for annexation as requested by the City Council of Farr West shall be described in **Attachment "A"** attached hereto and incorporated by this reference as if fully set out herein; and,

BE IT FURTHER RESOLVED that the type or types of services proposed to be provided to Far West include all fire prevention and suppression activities and services presently offered by the District, or as may be adopted or provided in the future, and,


BE IT FURTHER RESOLVED that a tax sufficient to pay for all such services which are or will be furnished as a result of this contemplated annexation will be annually levied upon all taxable property within Farr West City; and,

BE IT FURTHER RESOLVED that a time and place for a public hearing on the establishment of the area which shall be annexed shall be set not less than 30 nor more than 60 days after the adoption of this resolution, providing that all interested persons who desire to object shall be heard at that time and place.


BE IT FINALLY RESOLVED that this Resolution shall become effective immediately upon its passage, except that the aforementioned tax sufficient to pay for the aforementioned services shall not commence to be levied on all taxable property within Farr West City until December 31, 1997.
