County of Weber , State of Utah zip 84414 , for the sum of Dollars, and other good and valuable considerations, the following described tract of land in Weber County, State of Utah, to wit:

A tract of land situate in the SE1/4SE1/4 of Section 29 and NE1/4NE1/4 of Section 32, all in T. 7 N., R. 1 W., S.L.B.& M. also being part of Lot 42, Lot 46 and Lot 47, Plat "B", North Ogden Survey, Weber County, Utah. The boundaries of said tract of land are described as follows:

Beginning at the intersection of the westerly right of way line of Washington Boulevard and Southwesterly right-of-way line of the Pleasant View Drive at a point 175.89 feet N.0°15' E. along said westerly right of way line of Washington Boulevard from southeast corner of said Lot 47 also said point of beginning being described of record as being approximately 588 feet West and 190 feet south from the southeast corner of said Section 29; and running thence N.0°15' E. 191.58 feet (by measurement, but 223 feet by record) along said westerly right of way line of Washington Boulevard to the northeasterly right-of-way line of Pleasant View Drive; thence N. 44°38'37" W. 189.24 feet (by measurement, but N. 44°10' W. 198.24 feet by record) to a point on the north line of said Lot 46; thence N. 89°45' W. 56.19 feet (by measurement, but 60 feet by record) along said north line of said Lot 46 to the northwest corner thereof; thence N. 0°15' E. 6.34 feet along the west line of Lot 45; thence Northwesterly 157.82 feet along the arc of a 315.00-foot radius curve to right (Note: The central angel equals 24°42'25" and long chord bears to said curve N. 63°53'04" W. for a distance of 156.18 feet) to a point on said Southwesterly right-of-way line of Pleasant View Drive; thence along said Southwesterly right-of-way line of Pleasant View Drive the following three (3) courses and distance: (1) Southeasterly 159.50 along the arc of a 1869.86-foot radius curve to right (Note: The central angel equals 4°53'15" and long chord bears to said curve S. 47°05'15" E. for a distance of 159.45 feet); (2) S. 44°10' E. 180 feet; (3) southeasterly 225 feet along a arc of a curve to right to said westerly right of way line of Washington Boulevard to the point of beginning.
