E A S E M E N T

PROVO RESERVOIR WATER USERS COMPANY, a corporation of the State of Utah, Grantor, for and in consideration of a loan of \$55,750.50, does hereby convey and grant to the Utah Water and Power Board, Grantee, an easement and right of way over a strip of land known as the canal right of way over which has been constructed the Provo Reservoir Water Users Company canal located in Salt Lake County, beginning at a point on the Utah-Salt Lake County line, which point is approximately

for the purpose of conveying irrigation water through said canal, inspecting, maintaining, cleaning, reconstructing or replacing the canal or any of the headgates, bridges, roads, wells and well pumping equipment located on said canal right of way.

1. The Grantor reserves the right to convey irrigation water through said canal and to enter upon the property of said canal right of way at any time for the inspection, maintenance, cleaning, reconstruction or replacement of any of the canal or any of the headgates, bridges, roads, wells and well pumping equipment located on said canal right of way.

2. This easement is granted subject to the rights of the Grantor to recover said strip of land or canal right of way in its entirety upon completion of repayment of said \$55,750.50 to the Grantee.

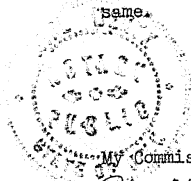
