HOFFMAN HEIGHTS #6, a subdivision in Salt Lake County, Utah, according to the plat thereof on file and of record in the office of the County Recorder of Salt Lake County, Utah, as Entry #1384706 in Book O of Plats, Page 39 thereof; and does hereby establish the nature of the use and enjoyment of all lots in said subdivision and that all conveyances of these lots shall be made subject to the following conditions, restrictions and stipulations:

- 1. Declaration of Building and Use Restrictions signed on August 11, 1954 in the Salt Lake County Recorders office, under Entry #1385057: In Book 1114 Page 284-285 is ammended and corrected as follows:
 - (a) Entry #1, which reads "Said lots shall be known and described as "Residential Building Lots" and used for purposes of residence only" should be corrected to read "Said lots shall be known and described as "Residential Building Lots" and used for purposes of residence only except for Lot 216 Block 40, which has been set aside for the purpose of construction of a church in accordance with County planning and zoning requirements.
