KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the undersigned are the fee titleholders and owners of all the land in Selma Subdivision according to the official plat thereof on file and of record in the office of the County Recorder of Salt Lake County, State of Utah, and

WHEREAS, Selma Subdivision is located in an unzoned area in Salt Lake County, and

WHEREAS, certain building restrictions and restrictive covenants have been recorded which provide in general for a minimum building set back of twenty five (25) feet from the front property line, except for a minimum set back of thirty (30) feet from one lot line on a corner lot, and provide for a minimum side yard of eight (8) feet on each side of a residential structure, and

WHEREAS, certain improvements on Lots 2, 3, 4, 10, 12, 15, 27, 28, and 29 have been constructed which fail to provide a full twenty-five (25) foot front set back at every point, and

WHEREAS, certain improvements on Lot 4 have been constructed which fail to provide a minimum set back of 30 feet from one lot line of this corner lot, and

WHEREAS, certain improvements on Lots 4, 12, 30 have been constructed in such manner as to fail to provide a full eight (8) foot side yard on each side of the structures, and

WHEREAS, it is the opinion of the owners that such structures as have been located in violation of building restrictions as mentioned above do not impair the value of the subdivision,
