DECLARATION OF THE ORGANIZATION OF THE
WANSHIP CEMETERY MAINTENANCE DISTRICT

WHEREAS, a petition has been filed with the clerk of the Board of Commissioners in and for Summit County, Utah, in accordance with the provisions of 8-1-2 and 8-1-3, Utah Code Annotated 1953, as amended, requesting the organization of Wanship Cemetery Maintenance District, said district being described as follows:

Beginning at the Northeast corner of Section 13, Township 1 North, Range 5 East, of the Salt Lake Base and Meridian, and running thence West to the Southeast corner of Section 10, T. 1 N., R. 4 E.; thence South to the Northwest corner of Section 11, T. 1 S., R. 4 E.; thence East to the Northeast corner of Section 11, T. 1 S., R. 4 E.; thence to the Southeast corner of Section 11, T. 1 S., R. 4 E.; thence East to the Southeast corner of Section 11, T. 1 S., R. 5 E.; thence North to the Northwest corner of Section 36, T. 1 N., R. 5 E.; thence East to the Northeast corner of Section 36, T. 1 N., R. 5 E.; thence North to the point of beginning, containing 30,720 acres more or less.

WHEREAS, a public hearing has been held upon such petition after due and proper notice in accordance with the provisions of 8-1-4, Utah Code Annotated 1953, as amended, and

WHEREAS, the clerk of the Board of Commissioners in and for Summit County has published a notice of election for the purpose of deciding whether the cemetery district should be organized and the votes having been canvassed and it appearing that a majority of those voting were in favor of the establishment of said district, which majority included more than one-third of all qualified voters in said district who paid a property tax in the year next preceding the election,


NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF SUMMIT, STATE OF UTAH, HEREBY declare the Wanship Cemetery Maintenance District as hereinbefore described duly organized in accordance with the provisions of the Cemetery Maintenance District Law, 8-1-15, Utah Code Annotated 1953, as



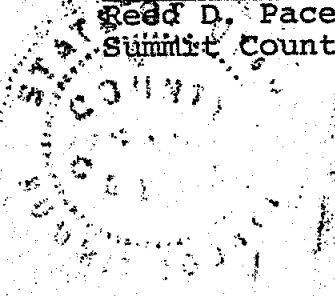
