DESIGNATION OF AUTHORIZED PARTY

This DESIGNATION OF AUTHORIZED PARTY (this “**Designation**”) is executed as of March 3, 2025 (the “**Effective Date**”) by HIGHLANDS AT ELK RIDGE, LLC, a Utah limited liability company (“**Declarant**”).

RECITALS

A. Declarant is the “Declarant” under that certain Declaration of Covenants, Conditions, and Restrictions for Highlands at Elk Ridge Phase 1, dated August 2, 2023, and recorded in the office of the Utah County Recorder on August 2, 2023, as Entry No. 50153:2023 (the “**Declaration**”).

B. Toll Southwest, LLC, a Delaware limited liability company (“**Toll**”) owns or is under contract with Declarant to purchase certain Lots (as defined in the Declaration), more particularly described in Exhibit A attached hereto, which are Lots subject to the Declaration.

C. Pursuant to Section 4 of the Declaration, Declarant and its authorized agents are permitted to erect or maintain temporary structures, trailers, improvements or signs necessary or convenient for the development, marketing or sale of Lots within the Subdivision (as defined in the Declaration) (collectively, the “**Construction and Marketing Rights**”).

D. Declarant desires to designate Toll as a party authorized to develop, market and sell the Lots owned by Toll (together with any additional Lots that Toll may acquire from Declarant in the future, the “**Toll Property**”), such that Toll may benefit from the Construction and Marketing Rights set forth in Section 4 of the Declaration with respect to the Toll Property.

DESIGNATION

NOW THEREFORE, Declarant does hereby designate Toll as a party authorized to develop, market and sell the Toll Property such that Toll may benefit from the Construction and Marketing Rights set forth in Section 4 of the Declaration with respect to the Toll Property. This Designation to Toll is expressly limited to those Lots actually owned by Toll at the time the Construction and Marketing Rights are exercised and shall not be exercised upon property within the Subdivision, as defined in the Declaration, owned by Declarant or any other third party. This Designation, and any rights, powers, or interests associated with the Construction and Marketing Rights, shall be subject to the terms of the Declaration.

This Designation expressly excludes any other rights of Declarant under the Declaration not expressly included in this Designation.

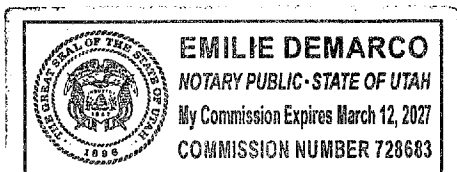
