Grantor(s), do hereby convey to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Carbon County, Utah, along the following described center line:

Beginning at an existing pole on the Grantors' land at a point 1030 feet south and 205 feet west, more or less, from the northeast corner of Section 12, T. 13 S., R. 8 E., S. L. M., thence N. 13° 55' E. 121 feet, thence N. 47° 54' W. 829 feet, thence N. 45° 18' W. 545 feet, thence N. 13° 42' W. 128 feet to an existing pole on said land and being in the NE 1/4 of the NE 1/4 of said Section 12, and in the SE 1/4 of the SE 1/4 of Section 1, Township and Range aforesaid.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
