THIS INDENTURE, dated as of the *2nd* day of *July*, 1957,
by and between SALT LAKE REFINING COMPANY, a corporation, hereinafter called
Grantor, and SALT LAKE PIPE LINE COMPANY, also a corporation, hereinafter called
Grantee;

WITNESSETH:

WHEREAS, Grantor is the holder and owner of two pipe line rights of way
in Salt Lake County, State of Utah, namely:

- (a) Grant of right of way in favor of Grantor dated August 20,
1953 from Stauffer Sand and Gravel Company, a corporation,
recorded as instrument number 1342084 on August 27, 1953
in Book 1030, Page 571 of Official Records, Records of said
Salt Lake County, affecting that certain parcel of land
more particularly described in said grant; and
- (b) Grant of right of way in favor of Grantor, dated August 20, 1953
from Harvey C. Woodbury and Lucille C. Woodbury, his wife, re-
corded as instrument number 1342085 on August 27, 1953 in Book
1030, Page 574 of Official Records, Records of said Salt Lake
County, affecting that certain parcel of land more particularly
described in said grant; and

WHEREAS, said grants of right of way include the right for Grantor to lay
an unlimited number of pipe lines within the strips of land described in said
grants; and

WHEREAS, Grantee is desirous of laying a pipe line and appurtenances
thereof on said rights of way and Grantor is willing to permit Grantee so to do;

NOW, THEREFORE, in consideration of the premises and other valuable
consideration given it therefor, receipt whereof is hereby acknowledged, Grantor,
in so far as it has the right so to do, does hereby grant, assign and transfer to
Grantee the right and privilege to construct, maintain and operate a pipe line and
appurtenances thereof on the above described rights of way, subject to and in
accordance with the terms and conditions as set forth in each of said divers
grants.

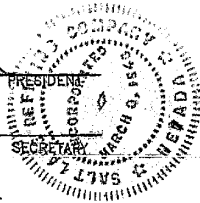
