

Right Of Way Deed

M.C. & Ella M. Curtis grantor, s
of Roy, County of Weber State of Utah,
hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for
the sum of One Hundred Ninety and No/100 DOLLARS,
the following described strip or parcel of land, as a perpetual right of way for highway purposes
across the grantors land in Weber County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 221 across the grantors
land in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 24, T. 5 N., R. 2 W., S. L. M. Said right of way is
contained within a parcel of land 50 ft. wide, 50 ft. on the south side of the center
line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the east right of way line of highway No. U. S.
91 and said center line of survey at Engineer's Station 0+50, which point is 17.52
ft. north and 50.0 ft. S.89°12'E., along said center line of survey, from the north-
west corner of said Section 24; thence S.89°12'E., 1188 ft. to the intersection of
said center line of survey at Engineer's Station 12+38 and the west right of way
line of the Davis and Weber Counties Canal, which point is 17.52 ft. north and 1238 ft. S.
89°12'E., along said center line of survey, from said northwest corner of Section 24,
as shown on the official map of said project on file in the office of the State Road
Commission of Utah. Above described parcel of land contains 1.36 acres, of which 1.16
acres are now occupied by the existing highway and the right of way of the Bamberger
Railroad. Balance 0.20 acre.

In executing this deed, the grantors hereby further grant to the grantee, the
right to use a strip of land 3 ft. wide adjoining the above described right of way
on the south side of said center line from Engineer's Station 0+50 to Station 12+38,
to be used for:

Constructing all cut or fill slopes made necessary by the grading for side-
walks upon above described right of way.

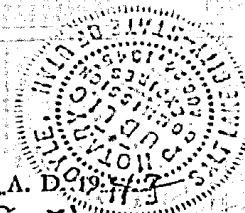
