

THAT PORTION OF THE SOUTH HALF OF SOUTHWEST QUARTER OF SECTION 9, TOWNSHIP 12 NORTH, RANGE 5 WEST, SLM, THAT LIES EAST OF THE STATE HIGHWAY AND WEST OF AN IRRIGATION CANAL DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT IN THE EAST RIGHT OF WAY LINE OF THE STATE HIGHWAY 49 FEET EAST OF THE SOUTHWEST CORNER OF SAID SECTION 9, AND RUNNING THENCE NORTH $89^{\circ}54'46''$ EAST 130.70 FEET TO THE WEST BANK OF AN IRRIGATION CANAL, THENCE ALONG SAID WEST BANK THE FOLLOWING 5 COURSES: NORTH $7^{\circ}05'14''$ EAST 189.22 FEET, THENCE NORTH $34^{\circ}29'29''$ EAST 47.37 FEET, NORTH $26^{\circ}21'39''$ EAST 180.25 FEET, THENCE NORTH $7^{\circ}38'$ WEST 104.08 FEET, THENCE NORTH $23^{\circ}11'04''$ WEST 236.63 FEET TO THE EAST RIGHT OF WAY LINE OF STATE HIGHWAY, THENCE SOUTHWESTERLY 613.57 FEET ALONG A CURVE WHOSE RADIUS IS 1380.03 FEET AND WHOSE CHORD BEARS SOUTH $12^{\circ}44'12''$ WEST 608.52 FEET TO THE STATE RIGHT OF WAY MARKER, THENCE SOUTH 117.06 FEET TO THE POINT OF BEGINNING.
