HERRICK, of Salt Lake County, State of Utah, GRANTOR, hereby bargains, sells, conveys, transfers, and delivers to SALT LAKE CITY, a municipal corporation of the State of Utah, GRANTEE, for and in consideration of the sum of ONE AND 00/100 (\$1.00) DOLLARS, in hand paid, and other good and valuable consideration, a permanent easement and right of way, including the perpetual right, to enter upon the real estate hereinafter described at any time that it may see fit and construct, maintain, replace and repair underground pipe lines and/or water mains for the purpose of conveying water over, across, through and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of said pipe line and/or mains, and the further right to remove trees, bushes and undergrowth and any other obstruction whatsoever interfering with the location, construction and maintenance of said pipe lines and/or mains and enter upon said property and do anything else whatsoever which may be incidental to the foregoing. The land affected by the grant of this easement and right of way is located in the County of Salt Lake, State of Utah, and is more particularly described as follows:

Beginning at the southeast corner of Lot 4, Block 14, Plat "B", which is center of aforesaid Block 14; thence west 200 feet; thence north 20 feet; thence east 200 feet; thence south 20 feet to point of beginning.
