Beginning at a point on the East section line of said  $E\frac{1}{2}$  of Section 9-18S-64W, which point of beginning is 698 feet in a northerly direction with and along said East section line from the Southeast corner of said  $E\frac{1}{2}$  of Section 9; thence North  $21^{\circ} 05'$  West, 2,354 feet to a point; thence North  $23^{\circ} 06'$  West, 2,546 feet to the point

of exit on the North section line of said E $\frac{1}{2}$  of Section 9, which point is 1,785 feet in a westerly direction with and along said North section line from the Northeast corner of said E $\frac{1}{2}$  of Section 9-18S-64W, being 296.97 rods in length, more or less, as shown on plat marked Exhibit "N" attached hereto and made a part hereof.

Tract No. 15

South Half (S $\frac{1}{2}$ ) and Northwest Quarter (NW $\frac{1}{4}$ ) of Section Four (4), Township Eighteen (18) South, Range Sixty-four (64) West, the centerline of said right of way, 50 feet in width, being more particularly described as follows:

Beginning at a point on the South section line of said S $\frac{1}{2}$  of Section 4-18S-64W, which point of beginning is 1,785 feet in a westerly direction with and along said South section line from the Southeast corner of said S $\frac{1}{2}$  of Section 4; thence North 23° 06' West, 314 feet to a point; thence North 21° 21' West, 5,326 feet to the point of exit on the North section line of said NW $\frac{1}{4}$  of Section 4, which point is 1,430 feet in an easterly direction with and along said North section line from the Northwest corner of said NW $\frac{1}{4}$  of Section 4-18S-64W, being 341.82 rods in length, more or less, as shown on plat marked Exhibit "O" attached hereto and made a part hereof.

Company shall bury the top of its pipe at least 40 inches below the surface of the ground; and Company further agrees that no above ground facilities shall be constructed on the above described lands.

The undersigned Owner, its successors, heirs, or assigns, reserves all oil, gas and minerals on and under said lands and the right to farm, graze and otherwise fully use and enjoy said lands, provided, however, that Company shall have the right hereafter to cut and keep clear all trees, brush and other obstructions that may injure, endanger or interfere with the construction and use of said pipeline, or fittings and appliances appurtenant thereto. Company shall have all privileges necessary or convenient for the full use of the rights herein granted, together with ingress and egress along said pipeline and over and across said lands, provided, however, that said right of ingress and egress shall be limited to existing roads, trail roads, or routes designated by Owner or to be so designated in the future by Owner.

The undersigned Owner, its successors, heirs or assigns, agrees not to build, construct or create any buildings or structures of any kind on the above described right of way, 50 feet in width, and not to build, construct, operate or maintain any street, road, roadway, alley or thoroughfare over and along the course of said right of way, 50 feet in width.

Company, by the acceptance hereof, agrees to pay for damage to crops, livestock, pasture, fences, and timber which may arise from laying, constructing, maintaining, operating, repairing, replacing, or removing said pipeline.

It is agreed that this right of way grant as written above covers all agreements between the parties and that no other representations have been made modifying, adding to, or changing the terms of the same.

This right of way agreement shall terminate upon abandonment by Colorado Interstate Gas Company, its successors or assigns, of its pipeline facilities on the above described lands.
