



Parcel 1: Beginning 13.15 chains West from the Northeast corner of the Southwest quarter of the Southeast quarter of Section 22, Township 15 South, Range 3 East, Salt Lake Base and Meridian; thence South $4^{\circ}15'$ West 4.70 chains, thence South 82° West 3.75 chains, thence North $4^{\circ}15'$ East 13.35 chains, thence North 82° East 3.75 chains, thence South $4^{\circ}15'$ West 8.65 chains to the point of beginning. (Serial No. 25639)

EXCEPTING all minerals in or under said land including, but not limited to metals, oil, gas, coal, stone and mineral rights, mining rights, and easements rights or other matters relating thereto, whether expressed or implied.
