Clayton R. Turrill, of the City, County and State of New York, the executor of the last will and testament of Julius A. Turrill, deceased, late of Salt Lake City, Utah, grantor, for the sum of Twenty-five (25.00) Dollars, paid to grantor by The Telluride Power Company, a Colorado corporation, hereby grants and conveys to said company, its successors and assigns, the right to erect and maintain one (1) line of poles and electric transmission circuits across the western part of the following described tract of land in Salt Lake County, Utah, to-wit:

The South-west one quarter(1/4) of the North-east one quarter (1/4) of Section numbered nine (9) of Township numbered one (1) north of range one (1) west of Salt Lake Meridian.

Said line shall pass on, over and across the above described tract of land as follows: Commencing thirty-three and two tenths (33.2) feet east of the centre of said section nine and thence northerly one quarter (1/4) of a mile to a point thirty-two and six tenths (32.6) feet east of the north-west corner of the south-west one quarter (1/4) of the north-east one quarter (1/4) of said section nine.

Ingress and egress to said line of poles for the purposes of erection, maintenance and repair of said line shall be confined to that portion of said premises lying and being west of said line of poles, and it is not the intention of the grantor in this instrument to grant the right of ingress and egress over any part of the said tract of land except as to that portion of said tract of land lying west of said line of poles; and further, whenever said grantee, its successors or assigns shall fail to maintain said line of poles and use them for the purposes herein granted, then this grant shall become void and of no further binding force or effect whatever, and the grantor, his heirs or assigns may renew said line of poles.
