Alexander C. Maclean and Susie Maclean his wife each of Salt Lake County, Utah, grantors for the sum of twenty two (22⁰⁰) Dollars, paid to grantors by the Telluride Power Company, a Colorado corporation, hereby grant to said company, its successors and assigns, the right to erect and maintain two (2) lines of poles and electric transmission circuits across the following described tracts of land in Salt Lake County, Utah, to-wit:

The South-west one-quarter ($\frac{1}{4}$) of the North-east one-quarter ($\frac{1}{4}$) and the North-west one-quarter ($\frac{1}{4}$) of the South-east one-quarter ($\frac{1}{4}$) and the North one-half ($\frac{1}{2}$) of the South-west one-quarter ($\frac{1}{4}$) of the South-east one-quarter ($\frac{1}{4}$) and the South one-half ($\frac{1}{2}$) of the South-west one-quarter ($\frac{1}{4}$) of the South-east one-quarter ($\frac{1}{4}$) of Section Numbered thirty-three (33) in Township numbered one (1) North of Range numbered one (1) West of Salt Lake Meridian. The said line of poles to be maintained over, on, through and across the above-described tracts where now constructed. This grant is given as to our undivided one-third ($\frac{1}{3}$) interest in the first three tracts of land above-described and as to our undivided one-half ($\frac{1}{2}$) interest only in the tract of land last above-described.

It being understood that said poles shall be sightly in appearance and not to exceed twenty two in number & to be so placed as not to be dangerous to pedestrians. That the grantee herein will hold grantors harmless from any damages that may be sustained by any person by reason of said poles being so placed on said land or by accident or injury sustained by anyone therefrom

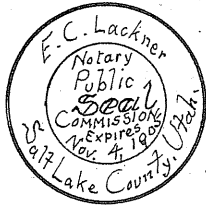
