being fully advised in the premises, and having heretofore made and entered Findings of Fact and Conclusions of Law,

IT IS NOW ORDERED, ADJUDGED and DECREED AS FOLLOWS:

- That plaintiff is the owner of the land hereinafter described in paragraph numbered 2 hereof, and has the rights-of-way as set forth in the sub-paragraphs designated as (a) (b) (c) and (d), and its title and rights thereto are hereby quieted as against all of the defendants herein; that said defendants and each of them, and all other persons claiming by, through or under them, are hereby enjoined and restrained from interfering with plaintiff's use thereof, and are debarred from asserting any claim or right to said land and rightsof-way adverse to plaintiff's ownership and rights.
- 2. The land and rights-of-way referred to in this decree are particularly described as follows:
