### DESCRIPTION:

A part of the Southeast Quarter of Section 14, Township 5 North, Range 2 West, of the Salt Lake Base and Meridian, United States Survey, beginning at a point 330 feet East from the Southeast corner of said Southeast Quarter of Section 14, and running thence North 2640 feet to the North line of said Southeast Quarter of Section 14, thence East 330 feet, thence South 2640 feet to the South line of Section 14, thence West 330 feet to the point of beginning.
