CERTIFICATE OF AMENDMENT

HOFFMAN HOMES, INC., :

WHEREAS, under date of June 12, 1958, Hoffman Homes, Inc., the owner of all of the property and premises situated in Salt Lake County, Utah, described as:

HOFFMAN HEIGHTS #21, a subdivision in Salt Lake County, Utah according to the plat thereof on file and of record in the office of the County Recorder of Salt Lake County, Utah, as Entry No. 1607114 in Book "S" of plats, Page 92, thereof,

established the nature of the use and enjoyment of all of the lots in said subdivision and pursuant thereto file in the Office of the Salt Lake County Recorder, a declaration of building and use restrictions as Entry No. 1607185 on August 21, 1958, and

WHEREAS, it, as the owner of the majority of the property has agreed to convey a portion thereof to the Board of Education of Granite School District, a Statutory Corporation so that said Board of Education may thereafter build a public school on said property, and

WHEREAS, it is necessary in order for the said Board of Education to take title to said premises and thereafter proceed with its building program, that the property to be conveyed to said Board of Education be excluded from the terms, conditions and covenants contained in said declaration, and

WHEREAS, Hoffman Homes, Inc., has secured the consent and agreement of other owners of property included within said subdivision known as Hoffman Heights #21,

NOW, THEREFORE, said declaration of building and use restrictions pertaining to Hoffman Heights #21 is hereby amended as follows by the addition of the following paragraph to be inserted as paragraph #11 to follow after paragraph #10 and immediately preceding the paragraph which begins "It is expressly understood * * * * *":

11. The above conditions, restrictions and stipulations shall not apply to all of block 114 designated on the Official Plat excepting Lots 106 to 119 inclusive, Hoffman Heights #21 subdivision, providing said property is conveyed to a Board of Education of a School District of the State of Utah and said Board of Education uses said property in connection with the construction and maintenance of school buildings and/or playgrounds in connection therewith.
