WHEREAS under date of July 16, 1949, Ernest Burbano executed and delivered to Salt Lake Pipe Line Company a grant of right of way which was recorded on the 5th day of August, 1949 as entry No. 107498 in Book 5, Page 307 of the official records in the office of the County Recorder of Davis County, State of Utah, and

WHEREAS said grant covered premises in the County of Davis, State of Utah, lying and being within the northwest quarter of the southeast quarter of Section 23, Township 5 North, Range 2 West, Salt Lake Base and Meridian, and

WHEREAS said grant did not specify the location within said quarter quarter section of said right of way or the location of the access rights thereto, held and enjoyed under said grant, and

WHEREAS request has been made to Salt Lake Pipe Line Company by the owners of the premises affected, to identify the location of its right of way and the area over which it may exercise rights of ingress and egress under said grant,

NOW THEREFORE, for such purpose, Salt Lake Pipe Line Company does hereby certify that the right of way held and enjoyed by it under said grant is confined to a strip of land 16.50 feet in width more particularly bounded and described as follows, to wit:

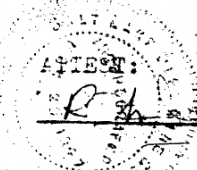
Beginning at the southwest corner of the northwest quarter of the southeast quarter of Section 23, Township 5 North, Range 2 West, Salt Lake Base and Meridian, in the town of sunset, County of Davis, State of Utah, thence north 699.6 feet more or less to the north line of Davis County; thence east along said County line 16.5 feet; thence south 699.6 feet; thence west 16.5 feet to the point of beginning.

And that in addition to said right of way Salt Lake Pipe Line Company holds and enjoys a right of ingress to and egress from said 16.50 foot

right of way over and upon an additional strip of land 33.50 feet in width, contiguous to and abutting upon the easterly side line of said right of way, and said Salt Lake Pipe Line Company hereby releases and relinquishes any right or interest in or to any premises covered by its said grant of July 16, 1949, other than the premises in this instrument identified and described.

IN WITNESS WHEREOF said Salt Lake Pipe Line Company has caused this instrument to be signed by its duly authorized officers and its corporate seal to be hereunto affixed, this 7 day of June, 1953.
