QUIT CLAIM DEED.

James H. Toomer and Lucy I. Toomer, husband and wife, grantors of Ogden County of Weber State of Utah, hereby Quit Claim to Bamberger Electric Railroad Company, a corporation of Utah, grantee of Salt Lake City, Utah for the sum of One DOLLARS the following described tracts of land in Weber County, State of Utah

A right of way; beginning at a point on the center line of the East track of the Bamberger Electric Railroad 400 feet South of the N.W. corner of the S. W. 1/4 of the N. E. 1/4 of Section 8, Tp. 5N Rg. 1 West and running thence N. 38°15' E. 385 feet; thence on a 2°30' curve (Radius 2292 feet) to the right 910 feet more or less, to the Northerly line of grantor's property; conveying a tract of land 75 feet wide on the Westerly side and 66 feet on the Easterly side of said line except where the toe of slope of the embankment on the Easterly side is in excess of 66 feet from said center line the boundry line shall be 3 feet beyond such slope.
