Grantor and Grantee have entered into a certain Easement Agreement ("Easement") pursuant to which Grantor has agreed to convey to Grantee an easement 20 ft. in width along an existing road for purposes of ingress and egress over, under, across and along the property described in Exhibit 1 attached hereto and incorporated herein by this reference; and

B. The parties desire to enter into this Memorandum of Easement for the purpose of setting forth certain terms and conditions of the Easement; and

C. Grantee and Grantor now desire to execute this Memorandum to provide constructive knowledge of Grantee's Easement.

NOW, THEREFORE, in consideration of the foregoing, the parties hereby agree as follows.

1. **Terms of Easement.** Grantor conveys to Grantee an easement 20 ft. in width along an existing road for a term of five (5) years, commencing on the 1st day of June, 2002 ("Commencement Date") and terminating on the last day of the month in which the fifth annual anniversary of the Commencement Date occurs, upon the terms and conditions set forth in the Easement. Grantee shall have the right to renew this Easement for five (5) additional 5-year terms.

2. **Provisions Binding on Grantor.** The Easement shall be binding upon and inure to the benefit of the parties and their respective heirs, successors and assigns, subject to the provisions of the Easement.

3. **Governing Law.** This Memorandum and Easement are governed by the laws of the state of Utah.

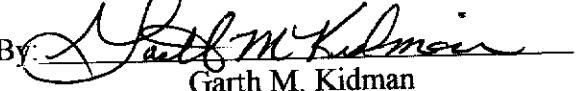
