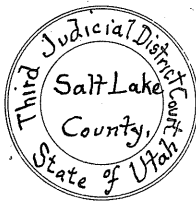

This case came on duly and regularly to be heard heretofore, testimony was taken, arguments heard and a judgment of condemnation entered herein, and also a judgment thereafter entered herein for the amount due the said defendant from the said plaintiff.

Now, after findings of fact, conclusions of law and judgment and decree have been duly made herein and filed, as required by law, and the said plaintiff having paid to the Clerk of said Court \$2539.09, the entire amount to which the said defendant is entitled under the judgment and decree herein:

Now, therefore, in consideration of the premises, it is hereby ordered, adjudged and decreed:

That the premises hereinafter described are hereby condemned for the occupation and use of said plaintiff for the purpose of operating and maintaining a steam railroad along, over and upon the same, for the purpose of public transportation, and said premises are situate in Salt Lake County, Utah, and are described as follows, to-wit:

A strip of land 100 feet wide, being 50 feet wide on each side of the center line of the proposed change of main line of the Rio Grande Western Railway, as the same is now located through part of the South-east quarter (1/4) of Section 1, and part of the North-east quarter (1/4) of Section 12, Township 2 South, Range 1 West, Salt Lake Base and Meridian; said center line is more fully described as follows, to-wit:

Beginning at the north boundary line of the Horn Silver property, at a point 1384 feet west and 1000 feet north of the South-east corner of said Section 1; thence running South 4 deg. 18' East 1736 feet to the South boundary of said Horn Silver property; also a strip of land in the said North-east 1/4 of Section 12, described as follows:

Beginning at the South-east corner of the strip of land hereinabove described; thence running North 4 deg. 18' West along the East boundary thereof 228 feet; thence North 85 deg. 42' East 25 feet; thence South 4 deg. 18' East 255 feet to the South boundary of the Horn Silver property; thence Westerly along said South boundary 26 feet, more or less, to the place of beginning; containing together 4.12 acres.

The title to the above described premises is hereby transferred and conveyed to the said plaintiff, its successors and assigns, forever, for the uses and purposes herein mentioned and described. And the said plaintiff is hereby directed to record a copy of this final order of condemnation with the County Recorder of said Salt Lake County, Utah.

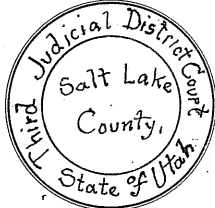
