

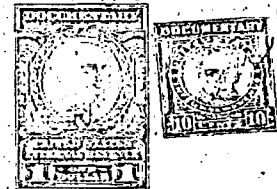
Right Of Way Deed

Etta M. Child grantor.
 of Rivendale County of Weber State of Utah,
 hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for
 the sum of Seven Hundred DOLLARS,
 the following described strip or parcel of land, as a perpetual right of way for highway purposes
 across the grantor's land in Weber County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 114-B across the grantors
 land in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ and Lot 4 of Section 7, T. 5 N., R. 1 W., S. L. M. Said right
 of way is contained within a parcel of land 120 ft. wide, 60 ft. on each side of
 the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the west boundary line of said grantors land
 and said center line of survey at Engineer's Station 83+10, which point is 85.9 ft.
 southerly along the west boundary line produced of said Section 7 and 1196.2 ft.
 N.64°15'E. along said center line of survey, from the southwest corner of said
 Section 7; thence N.64°15'E., 402 ft. to the intersection of said center line of
 survey at Engineer's Station 87+12 and the north boundary line of said grantors
 land, which point is 85.9 ft. southerly along said west boundary line produced of Sec-
 tion 7 and 1598.2 ft. N.64°15'E. along said said center line of survey from said
 southwest corner of Section 7 as shown on the official map of said project on file
 in the office of the State Road Commission of Utah. Above described parcel of land
 contains 1.09 acres.

In executing this deed, the grantor hereby grants to the State Road Commis-
 sion of Utah permission to locate and construct within the grantors land and outside
 the limits of above described right of way, all irrigation ditches made necessary
 by the construction of said project.
