

UNITED STATES DEPARTMENT OF AGRICULTURE  
FARMERS HOME ADMINISTRATIONPIPE LINE AGREEMENT

THIS AGREEMENT, Made and entered into this 19th day of September,  
1949, by and between the Board of Commissioners of Weber County, State of Utah,  
pursuant to and as authorized by action of the Board at its regular meeting held  
September 19th, 1949, party of the first part, and the Eden Water-  
works Company, a corporation duly organized and existing under the laws of the  
State of Utah, party of the second part:

WITNESSETH, That for and in consideration of the sum of One Dollar (\$1.00)  
paid by the party of the second part to the party of the first part, and the  
express covenants and agreements herein contained, all of which are agreed to  
be sufficient consideration to support this contract, the party of the first  
part hereby grants to the said party of the second part the right to construct  
and install, and thereafter use and maintain a metal water pipe line along, under  
and across the county road right-of-way located along all the County roads in the  
Eden area.

The Pipe line is to be placed Sections 22, 27, 28, 34 and 35 in Township  
7 North and Section 2, in Township 6 North, all in Range 1 East,  
Salt Lake Base and Meridian, U.S. Survey

FOR AND IN Consideration of the above the party of the second part agrees as  
follows: 1,2+3

1. To bear the entire expense in connection with the construction, maintenance and renewal of said pipe line.
2. To construct and at all times maintain, repair and renew said pipe line in such a manner as to cause no interference whatsoever with the constant, continuous and uninterrupted use of the road.
3. To be solely responsible and liable for any damages to the road or adjoining property resulting from the construction and use of said pipe line, and assume all liability of any accident.
4. The party of the first part consents to the mortgaging of this agreement to the United States.
