AN ORDINANCE

AN ORDINANCE VACATING an alley in Block 2, Chas. S. Desky's 3rd Addition, all abutting property owners having petitioned for the vacation.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That the following described property in Block 2, Chas. S. Desky's 3rd Addition, be, and the same hereby is, vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way:

Commencing at the S.E. corner of Lot 8, Block 2, Charles S. Desky's 3rd Addition, Sec. 34, Township 1 North Range 1 West, Salt Lake Base and Meridian; thence west 115.5 feet; south 11.2 feet; east 115.5 ft; north 11.2 feet to beginning.

Said vacation is made expressly subject to all existing rights of way, and easements of all public utilities of any and every description now located in, on, under or over the confines of the above described property; and also subject to the rights of entry thereon for the purpose of inspecting, maintaining, repairing, replacing, removing, altering or reputeing said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners of Salt Lake City, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City, Utah, that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.

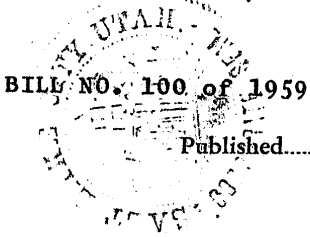
