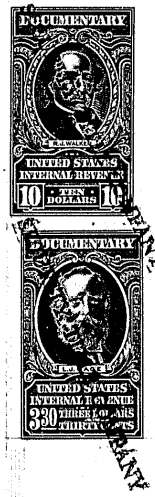

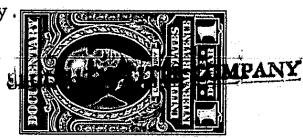
WARRANTY DEED

and other good and valuable consideration,
the following described tract of land in Salt Lake County,
State of Utah:



Beginning on the South side of A County Road approximately 33 feet South and 610 feet East from the center of Section 6, Township 4 South, Range 1 East, Salt Lake Meridian, and running thence East 610 feet more or less, to a point 100 feet West of the East line of the Northwest quarter of the Southeast quarter of said Section 6; thence South 1287 feet, more or less, to a point 100 feet West of the Southeast corner of the Northwest quarter of the Southeast quarter of said Section 6; thence West 352 feet; thence North 1153.9 feet, more or less, to the South bank of the East Jordan Canal; thence along the South bank of said canal South 46°34' West 354.76 feet, more or less, to a point which is due South of the place of beginning; thence North 475 feet, more or less, to the place of beginning; reserving to the Sellers one-half (1/2) of all mineral and oil rights in and to the said property.
