AN ORDINANCE

AN ORDINANCE VACATING
an alley running east and west
north of Third South Street be-
tween Fourteenth West Street and
Foss Street, all abutting property
owners having petitioned for the
vacation.

Be it ordained by the Board of
Commissioners of Salt Lake City,
Utah:

SECTION 1. That an alley run-
ning east and west north of Third
South Street between Fourteenth
West Street and Foss Street, more
particularly described as follows,
be, and the same hereby is, va-
cated and declared no longer to be
public property for use as a street,
avenue, alley or pedestrian way:

Beginning at the northeast
corner of Lot 1, Block 1, Irving
Park Addition, a part of Section
3, Township 1 South, Range 1
West, Salt Lake Base and Meridi-
an thence West 120.0 feet to
the northwest corner of Lot 5,
of said Block 1; thence North
12.0 feet to the southwest cor-
ner of Lot 6, of aforesaid Block
1; thence East 120.0 feet to the
southeast corner of said Lot 6;
thence South 12.0 feet to the
point of beginning.

Said vacation is made expressly
subject to all existing rights of
way and easements of all public
utilities of any and every descrip-
tion now located in, on, under or
over the confines of the above de-
scribed property; and also subject
to the rights of entry thereon for
the altering or rerouting said
utilities and all of them.

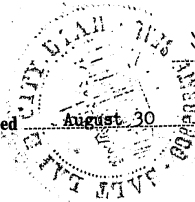
