RESTRICTIONS 2933 E. 33rd South S. L.C.

KNOW ALL MIN BY THUSE PRESENTS:

The undersigned owners of the following described property situate in Salt Lake County, Uteh, to-wit:

> All Lots inclusive of DRIFTWOOD ESTATES SUDDIVISION, according to the plat thereof, recorded in the office of the County Recorder of said County.

are desirous of creating restrictions and covenents affecting said property.

NEW THEREFORE, in consideration of the premises, the undereigned hereby declare the property hereinshove described subject to the following restrictions and coveranto:

- 1. No lot shall be used except for residential purposes. No building shall be oracted, altered, placed, or permitted to remain on any lot other than one detached single family duelling not to exceed two stories in height and a private garage for not more than two cars.
- 2. No building shall be erected, placed or altered on any building plot in the above described property until the building plans, specifications, and plot plan chowing the location of such building have been approved in writing as to conformity and harmony of external design with existing structures in the said property, and as to location of the building with respect to topography and finished ground clavation, by a committee composed of GEORGE K. PROTHERO, STAN MEAFFEE, and GORDON RETNOIDS or by a representative designated by a majority of the members of the cald committee. In the event of death or resignation of any member of said committee, the remaining member, or members of the said committee, shall have full authority to approve or disapprove such designs and locations within thirty days after sold plans and specifications have been submitted to, it or in any event, if no suit to enjoin the crection of such buildings or the making of such alterations has been commenced prior to the completion thereof, such approval will not be required and this covenant will be deemed to have been fully complied with. Noither the members of such committee, nor its designated representative shall be entitled to any compensation for services performed pursuant to this covenant. The powers and duties of such committee, and of its designated representative, shall cease on or after January 1, 1990. Thereafter, the approval described in this covenant shall not be required, unless, prior to said date and effective thereon, a written instrument shall be executed by the then record owners of a majority of the lote in eaid subdivision and duly recorded appointing a representative, or representatives, who chall hereafter exercise the same powers previously exercised by said countities.
- 3. No dwelling shall be permitted on any lot unless the ground floor area of the main structure, exclusive of one story open porches and garages, is not less than 1000 square feet.
- 4. No building shall be located on any residential building plot nearer than 30 feet to the front lot line, nearer than 8 feet to any side lot line, or a total of 18 feet on the 2 side yards, except in the case of an attached carport or attached garage a total of 16 feet on the 2 side yards, or nearor than 20 feet to any side street line. In the case of an attached garage, it shall be no nearer than 20 feet to any side street line or nearer than 8 feet to any side lot line. No detached garage shall be nearer than 45 feet to any front lot line, nearer than 8 feet to any side street line, or nearcr than 2 feet to any side or rear lot line.
- 5. No dwelling shall be erected or placed on any lot having a width of less then 75 feet at the minimum satback line nor shall any dwalling be erected or placed on any lot having an area of less than 10,000 square feet.

- 6. Easements for installation and maintenance of utilities and drainage facilities are reserved as shows on the recorded plat and over the rear five fact of each lot.
- 7. No norious or offensive trade or activity shall be carried on upon any lot, nor chall snything be done thereon which may be or may become an annoyance or nuisance to the neighborhood. The nations heights on any fence shall be six feet and shall not extend beyond the front sakback of the dwelling, and shall not extend beyond the sexback on any front or side excet, provided however, that the building committee shall have power to grant variances for retaining wells to extend beyond the front setback line.
- 8. No otructure of a temporary character, trailer, basement, tent, shack, garage, barn, or other outbuilding shall be used on any lot at any time as a residence either temporarily or permanently.
- 9. These covenants are to run with the land and shell be binding on all parties and all persons claiming under them for a period of thirty years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive periods of 10 years unless an instrument signed by the majority of the then owners of the lots has been recorded, agreeing to change said covenants in whole or in part.
- 10. ) Enforcement shall be by proceedings at law or in equity against any person or persons violating or attempting to violate any coverants either to restrain violations or to recover desages.
- 11. Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.
