 land and said right of way line, which point is 1111.44 ft. south and 72.85 ft.
 S.78°30'E., and 599.6 ft. S.78°15'E., from the NW corner of said Section 8; thence
 N.38°15'E., 181.7 ft. along said northwesterly right of way line; thence N.51°45'W.,
 10.0 ft.; thence S.38°15'W., 100.0 ft.; thence N.51°45'W., 10.0 ft.; thence S.38°
 15'W., 91.7 ft., to said south boundary line; thence S.78°15'E., 22.3 ft. to the

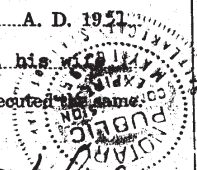
