 of Ten and No Cents (and other valuable consideration), Dollars,

A perpetual easement, upon part of an entire tract of property in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 29, T. 3 S., R. 5 E., S.L.B. & M, for the purpose of constructing thereon drainage facilities, and appurtenant parts thereof, incident the widening of Highway State Route 40,

Said perpetual easement is a strip of land 30 feet wide adjoining westerly the following described portion of a 15 foot irrigation easement adjoining the westerly right of way and limited access line of said highway:

Beginning in the westerly line of a 15 foot irrigation and slope easement that adjoins the westerly right of way and limited access line of said highway at a point 90 feet radially distant westerly from the centerline of said project, opposite Engineer Station 250+30, which point is also approximately 940 feet south and 1315 feet east from the Northwest corner of said Section 29; and running thence Northerly 40 feet, more or less, along said westerly line. The above described parcel contains 1200 sq. ft. or 0.028 acre in area.

After said irrigation ditches are constructed on the above described part of an entire tract at the expense of the Utah Department of Transportation, said Utah Department of Transportation is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said irrigation ditches and appurtenant parts thereof.
