**DECREE OF DIVORCE  
AND JUDGMENT**

This divorce action is before the court on **Cindy Xiu Ying Huang's** VERIFIED PETITION FOR DIVORCE. The Court having found and entered its FINDINGS OF FACT AND CONCLUSIONS OF LAW and being otherwise fully advised, adjudges and decrees as follows:

**DIVORCE**

1. **Cindy Xiu Ying Huang** is granted a divorce based on her Affidavit of Jurisdiction and Grounds, the divorce to become final upon entry.

**CHILDREN**

2. There are no unborn or minor children from this marriage. There are no children of this marriage as defined in Utah Code 78B-12-102(7)(a). There are either no adult children from this marriage eligible for child support as defined in Utah Code 78B-12-102(7)(b) and (c), or, **Cindy Xiu Ying Huang** is not asking the court to establish a child support order for any adult child who may be eligible under Utah law.

**FEDERAL EMPLOYEE RETIREMENT SYSTEM BENEFITS**



**DUTY TO SIGN DOCUMENTS WHICH IMPLEMENT DECREE OF DIVORCE**

11. Both parties are ordered to sign and fully execute whatever documents are necessary for the implementation of the provisions of their divorce decree. Should a party fail to execute a document within 60 days of the entry of their divorce decree, the other party may bring an Order to Show Cause at the expense of the disobedient party and ask that the Court appoint some other person to execute the document pursuant to Rule 70 of the Utah Rules of Civil Procedure. Any document executed pursuant to Rule 70 has the same effect as if executed by the disobedient party.
