PARCEL 1:

Beginning at the Southeast Corner of Lot 41, TAYLOR FARM ESTATES SUBDIVISION, PLAT "A", said point also being North 41.48 feet and East 1632.56 feet (Based on Utah State Coordinate System Bearings) from the Southwest Corner of Section 28, Township 7 South, Range 3 East, Salt Lake Base and Meridian; thence North 00°08'40" West 135.51 feet; thence South 89°36'50" East along a fence line 73.70 feet; thence South 00°10'52" West along a fence line 132.68 feet; thence South 88°10'09" West 72.97 feet to the point of beginning.
