A RESOLUTION REAPPOINTING PRESENT BOARD MEMBERS TO THE BOARD OF TRUSTEES OF THE WEBER COUNTY INDUSTRIAL SERVICE AREA NO. 1

WHEREAS, the Weber County Industrial Service Area No. 1 ("Service Area") was created by County Ordinance 21-78 on the 8th day of August, 1978; and

WHEREAS, the originating Ordinance provided that the governing body of the Service Area should be a Board of Trustees consisting of five (5) members with the responsibility to supervise and control all of the activities of the Service Area; and

WHEREAS, records relating to interim appointments of the Service Area indicate that such appointments have not been made in accordance with statutory provisions; and

WHEREAS, the Board of Trustees of the Service Area has requested that the legislative body of the County now make appointments in accordance with statutory provisions; and

WHEREAS, the Utah State Legislature has now provided that all terms of appointment for districts and service areas begin and end on the first Monday of January in the year of expiration; and

WHEREAS, the present Board of Trustees of the Service Area has requested that the County Legislative Body reappoint the Board Members as specified below;

NOW THEREFORE, the Board of County Commissioners of Weber County hereby resolves as follows:

- 1. Rick Probst, Randy Marriott, and Ron Kusina are hereby appointed to the Board of Trustees of the Weber County Industrial Service Area No. 1 for terms beginning immediately and extending until 12 noon on the first Monday in January, 2007.
- 2. Kevin Merchel, Kent Bradford, Lance Wood and Ken Bischoff are hereby appointed to the Board of Trustees of the Weber County Industrial Service Area No. 1 for terms beginning immediately and extending until 12 noon on the first Monday in January, 2005. Kevin Merchel and Kent Bradford's appointments are subject to the Service Area expanding the Board to seven members at their next meeting pursuant to Utah Code Annotated Section 17B-2-402, 1953 as amended.
- 3. Any subsequent vacancy shall be filled in accordance with the Utah Code provisions governing the filling of vacancies on the Board of Trustees.
- 4. As a records search indicates that the original ordinance creating the service area was not recorded, the County Clerk/Auditor is hereby directed to record a copy of that ordinance.
