In addition, the Special Service District shall be empowered to administer acquisition and distribution of waters for use of residents within the District, to provide culinary and irrigation waters, construct water distribution facilities, and to oversee and administer special improvements within the District. PROPOSED SERVICES

The proposed District shall be empowered to administer acquisition and distribution of waters for use of residents within the District, to provide culinary and irrigation waters, construct water distribution facilities and oversee and administer special improvements within the District. In addition, the District shall have the power to create improvement districts pursuant to Utah Code Ann. § 17A-3-301, et seq., to make and finance improvements within the District.

METHODS OF FINANCE

Taxes may be annually levied upon all taxable property within the district to pay for improvements that are necessary to upgrade or expand the current water delivery system and fees and charges may be imposed to pay for all or part of the services to be provided by the District.

PUBLIC HEARING ON PROPOSED DISTRICT

The City Council has determined that the creation of the District is in the public interest to ensure that the residents of Midway City enjoy a dependable and affordable supply

of water and to provide adequate planning for the future water needs of the community. A hearing has been scheduled for 6:30 p.m. on the 4th day of January, 1996, 1995 at City Council Chambers, Midway, Utah to discuss the creation of the District and receive public comments.

Approval of Previous Minutes:
