WARRANTY DEED

BOARD OF EDUCATION OF SALT LAKE CITY, a public corporation, grantor,
hereby conveys and warrants to PEAK IMPROVEMENT CO., a corporation of the
State of Utah, grantee, the following described tract of land in Salt Lake
City, Salt Lake County, State of Utah, particularly described as follows:

Beginning at a point which is 42.07 feet N. 0°01'57" W.
and 58.687 feet N. 75°09'12" W. from a Salt Lake City Monument
located at the intersection of Wasatch Boulevard & Virginia
Street; said point of beginning also being located 179.23 feet
N. 89°58'03" E. and 553.06 feet N. 0°00'24" W. from the West
Quarter Corner of Section 33, T. 1 N., R. 1 E., S.L.B.&M., and
running thence N. 0°00'24" W. 476.58 feet; thence N. 89°58'03"
E. 1300.00 feet; thence S. 15°00' W. 120.00 feet; thence S.
79°30' W. 1100.00 feet; thence S. 45° W. 116.78 feet; thence
South 106.14 feet; thence N. 75°09'12" W. 108.35 feet to the
point of beginning, consisting of 7.256 acres.

In consideration of this conveyance, the grantee covenants and agrees
to construct and maintain a 66 foot street on that portion of said property
described as follows:

Beginning at a point which is 42.07 feet N. 0°10'57" W.
from a Salt Lake City Monument at the intersection of Wasatch
Boulevard & Virginia Street; said point being also 236.15 feet
N. 89°58'03" E. & 537.99 feet N. 0°01'57" W. from the West
Quarter Corner of Section 33, T. 1 N., R. 1 E., S.L.B.&M. and
running thence N. 75°09'12" W. 34.15 feet; thence N. 0°01'57"
W. 107.10 feet; thence Northerly along the arc of a curve to
the right (radius 208.00 feet, bearing N. 89°58'03" E.) 297.80
feet; thence N. 82° E. 861.43 feet; thence Northeasterly along
the arc of a curve left (radius 197.00 feet, bearing N. 8° W.)
126.40 feet; thence N. 89°58'03" E. 85.94 feet; thence South-
westerly along the arc of a curve to right (radius 263.00 feet,
bearing N. 56°38'59" W.) 223.31 feet; thence S. 82° W. 861.43
feet; thence Southerly along the arc of a curve to the left
(radius 142.00 feet, bearing S. 8° E.) 203.31 feet; thence S.
0°01'57" E. 124.63 feet; thence N. 75°09'12" W. 34.15 feet to
the point of beginning,

with curb, gutter, sidewalk and storm sewer, all to be in accordance with
specifications, ordinances and code requirements of Salt Lake City. Said
sewer shall be adequate to drain the Arlington Heights Subdivision and any
other areas draining into and from Arlington Heights Subdivision. In
addition to the foregoing covenants, grantee shall pay grantor \$36,280.00,
the receipt of which is hereby acknowledged simultaneous with delivery of this
deed.

Revenue

Grantor reserves an easement for all such access roads as it may at any time desire to and from said 66 foot street for the benefit of adjacent property of the grantor.

In the event of the failure of the grantee, its successors and assigns, to construct and maintain said 66 foot street with curb, gutter, sidewalk and storm sewer, the title to the property herein conveyed shall revert to the grantor and grantor shall have the right to re-enter and repossess said property.
