SALT LAKE CITY, a municipal corporation of the State of Utah, hereby grants permission to The Mountain States Telephone and Telegraph Company, hereinafter referred to as Permittee, its successors and assigns, to install, maintain and operate an underground conduit and cable only to be located on the following described property in Salt Lake City, Salt Lake County, Utah,

Beginning 144 ft. south of the Northwest corner, Lot 22, Cottonwood Estates Subdivision in the Northeast Quarter of Sec. 15, T.2 S., R.1 E., Salt Lake Base and Meridian; thence West 10 ft.; thence South 5 ft.; thence East 10 ft.; thence North 5 ft. to beginning,

subject to the following conditions:

IT IS UNDERSTOOD AND AGREED that the above described property is a part of the East Jordan extension canal right of way and that said canal is used to transport water to the various landowners and water users; that the installation, maintenance and use of said underground conduit and cable shall not in any manner interfere with the use of said canal for transporting water or in cleaning or maintaining the same; that the said Permittee shall be solely responsible for the facilities placed by it hereunder and for any damage thereto that may result to the same in the course of operating, cleaning and maintaining said canal; that should said facilities in anywise interfere with the use of said canal by Salt Lake City in transporting water or in maintaining or cleaning said canal, the same shall be removed and the above described property restored, all at the expense of said Permittee.
