THIS DECLARATION (this "Declaration") is entered into as of the 15 day of July, 1996, between TRANS-WASATCH COMPANY, L.L.C., a Utah limited liability company ("Trans-Wasatch"), whose address is 190 North Main Street, Heber City, Utah 84032, Attention: H. McKay Edwards, Chief Operating Officer, and DEER CREST ASSOCIATES I, L.C., a Utah limited liability company ("DCA"), whose address is c/o LCC Properties Group, L.C., 2121 Avenue of the Stars, Suite 1700, Los Angeles, California 90067, Attention: David M. Luber, managing member.

FOR THE SUM OF TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Trans-Wasatch and DCA agree as follows:

- 1. <u>Definitions</u>. As used in this Declaration, each of the following terms shall have the indicated meaning:
 - 1.1. "Association" means the Master Association or a Sub-Association.
- 1.2. "BLM Land" means the real property located in Summit County, Utah that is covered by the BLM Permit, as such real property currently is, or after the date of this Declaration may be, described in the BLM Permit. An approximate metes and bounds description of the BLM Land, as it is currently described in the BLM Permit, is set forth on the attached Exhibit <u>A</u>.
- "BLM Permit" means the United States Department of the Interior, Bureau 1.3. of Land Management, Right-of-Way Grant/Temporary Use Permit, Serial Number UTU-68297, as the same may be modified, amended or supplemented after the date of this Declaration.
- "DCA Parcel" means the real property located in Summit County and Wasatch County, Utah, described on the attached Exhibit B. As of the date of this Declaration, the DCA Parcel is owned by DCA.
- "Emergency Access" means that portion of the Roadways over which the Jordanelle Parcel is granted certain rights-of-way and easements pursuant to Paragraph 2.2, and is the real property located in Summit County and Wasatch County, Utah, described on the attached Exhibit C. As of the date of this Declaration, the Emergency Access is owned by DCA.

- 1.6. "Hidden Hollow Parcel" means the real property located in Summit County, Utah, described on the attached Exhibit D. As of the date of this Declaration, the Hidden Hollow Parcel is owned by Trans-Wasatch.
- 1.7. "Jordanelle Parcel" means the real property located in Wasatch County, Utah, described on the attached Exhibit E. As of the date of this Declaration, the Jordanelle Parcel is owned by DCA. The Jordanelle Parcel is generally depicted as the "Telemark Village Parcel" on the 1996 Amended Density Application filed with Wasatch County.
- 1.8. "Master Association" means the master association created for the integrated maintenance and management of the Parcels, having the right to make assessments and impose liens on the Parcels, and to foreclose such liens.
- 1.9. "Mortgage" means a mortgage or a deed of trust recorded in the official records.
- 1.10. "Mortgagee" means the mortgagee under a mortgage, or the beneficiary under a deed of trust, recorded in the official records.
- 1.11. "Official records" means the official records of the Summit County Recorder and/or the Wasatch County Recorder, State of Utah, as applicable.
- 1.12. "Owner" means the person that at the time concerned is the legal owner of record (in the official records) of a whole or undivided fee interest in any portion of any Parcel. Notwithstanding any applicable theory relating to a Mortgage, the term "Owner" shall not mean a Mortgagee unless and until such Mortgagee has acquired title to the Parcel concerned pursuant to foreclosure or any arrangement or proceeding in lieu of foreclosure.
- 1.13. "Parcels" means the DCA Parcel, the Hidden Hollow Parcel and the Jordanelle Parcel, collectively, and "Parcel" means any of the DCA Parcel, the Hidden Hollow Parcel or the Jordanelle Parcel, individually, where no distinction is required by the context in which such term is used.
- 1.14. "Party in Interest" means (a) initially, the Owner of the portion of the Parcel concerned, and (b) after a Transfer (as defined in Paragraph 5) by such Owner to an Association in accordance with Paragraph 5, such Association with respect to the portion of the Parcel concerned.
- 1.15. "Roadways" means the real property located in Summit County and Wasatch County, Utah, described on the attached Exhibit F. As of the date of this Declaration, portions of the Roadways are owned by Trans-Wasatch, and portions of the Roadways are owned by DCA.
- 1.16. "Slalom Village Bypass Road" means that portion of the Roadways referred to in Paragraph 11.4, and is the real property located in Wasatch County, Utah, described on the attached Exhibit G. As of the date of this Declaration, the Slalom Village Bypass Road is owned by DCA.

- 1.17. "Snowtop Property" means the real property located in Wasatch County, Utah, described on the attached Exhibit H. As of the date of this Declaration, the Snowtop Property is owned by DCA.
- 1.18. "Sub-Association" means a homeowners association formed with respect to any portion of the Parcels for the administration of one or more subdivisions created within the Parcels. It is contemplated that each Sub-Association will be a member of the Master Association.
 - 2. Rights-of-Way and Easements.

- 2.1. Rights-of-Way and Easements Over Roadways.
- 2.1.1. Access Right-of-Way and Easement. Each portion of the DCA Parcel and the Hidden Hollow Parcel shall have appurtenant thereto and shall be benefitted by, and the Roadways shall be subject to and shall be burdened by, a perpetual, non-exclusive right-of-way and easement in favor of the DCA Parcel and the Hidden Hollow Parcel Parties in Interest for pedestrian and vehicular ingress and egress on, over and across the Roadways.
- 2.1.2. Utilities Right-of-Way and Easement. Each portion of the DCA Parcel and the Hidden Hollow Parcel shall have appurtenant thereto and shall be benefitted by, and the Roadways shall be subject to and shall be burdened by, a perpetual, non-exclusive right-of-way and easement in favor of the DCA Parcel and the Hidden Hollow Parcel Parties in Interest for the laying, construction, installation, operation, inspection, servicing, maintenance, repair, removal, alteration, enlargement, relocation and replacement of underground utility pipes, lines, wires, conduits and related facilities (including, without limitation, pipes, lines, wires, conduits and related facilities for electricity, natural gas, other fuels or power sources, telephone, sewage, storm drainage and all types of water) under, through and across the Roadways, including the right to excavate or conduct construction activities on the Roadways. All activities referred to in the foregoing portion of this Paragraph 2.1.2 shall be (a) performed in a good and workmanlike manner, (b) prosecuted diligently to completion, and (c) conducted only after obtaining all necessary governmental permits and in conformance with all applicable rules, regulations, ordinances and codes. On completion of such activities, the Party in Interest performing such activities shall immediately restore any previously improved portion of the Roadways to the same condition as existed prior to the commencement of such activities, using the same type and quality of materials previously used, or such other type and quality of materials as may be required by any governmental agency having jurisdiction.
- 2.2. <u>Right-of-Way and Easement Over Emergency Access</u>. Each portion of the Jordanelle Parcel shall have appurtenant thereto and shall be benefitted by, and the Emergency Access shall be subject to and shall be burdened by, a perpetual, non-exclusive right-of-way and easement in favor of the Jordanelle Parcel Parties in Interest for pedestrian and vehicular ingress and egress on, over and across the Roadways, but only for emergency access.
- 2.3. Right-of-Way Over BLM Land. Subject to all of the terms and conditions of the BLM Permit, Trans-Wasatch grants to the DCA Parcel Parties in Interest, and agrees that each portion of the DCA Parcel shall have appurtenant thereto and shall be benefitted by, and the BLM Land shall be subject to and shall be burdened by, a non-exclusive right-of-way and right in

favor of the DCA Parcel Parties in Interest to construct, operate and maintain an existing road over and across the BLM Land, as set forth in the BLM Permit. Trans-Wasatch reserves to itself, on a non-exclusive basis, all of its right, title and interest under the BLM Permit, and the foregoing grant and agreement is made with the intent that the DCA Parcel Parties in Interest use the right-of-way and right granted under the BLM Permit jointly with Trans-Wasatch and its successors and assigns.

- 2.4. Restoration of Damage. Any Party in Interest exercising any of the rights-of-way and easements set forth in this Paragraph 2 shall restore and repair any damage caused by such Party in Interest in such exercise to the same condition as existed prior to such damage, using the same type and quality of materials previously used, or such other type and quality of materials as may be required by any governmental agency having jurisdiction.
- Maintenance of Roadways. Once improved, the Roadways shall at all times be properly surfaced with asphalt, concrete, gravel or other similar material, as permitted and/or specified by the applicable governmental entity. The Parties in Interest with respect to each portion of the Roadways shall at all times maintain or cause to be maintained such portion in a reasonably good, clean and safe condition and repair, reasonably free from debris, rubbish, snow, ice and other materials. If any Party in Interest fails to comply with the provisions of the preceding sentence, or fails to comply with any other provision of this Declaration, any other Party in Interest may (but is not obligated to), after giving twenty (20) days' written notice to the noncomplying Party in Interest, perform or cause to be performed such work as is necessary to cause the Roadways to so comply, or perform such acts or pay such amounts as are necessary to cause the compliance with any other provision of this Declaration. In such event, all sums reasonably expended and all costs and expenses reasonably incurred by the performing Party in Interest in connection with such work, performance or payment shall bear interest from the date expended or incurred (as the case may be) at the rate of fifteen percent (15%) per annum until paid or otherwise satisfied in full, and shall be paid promptly to such performing Party in Interest by the noncomplying Party in Interest on written demand.

4. No Interference; Emergency Crash Gates.

- 4.1. No Interference. Except as provided in Paragraph 4.2, and except to the extent necessary (on a temporary basis) for reasonable construction, for repair and maintenance, for traffic regulation and control or to prevent a public dedication or the accrual of any rights to the public, no fence, gate, wall, barricade or other obstruction, whether temporary or permanent in nature, which limits or impairs the free and unimpeded use of the rights-of-way and easements granted in Paragraph 2 shall be constructed or erected, nor shall any Party in Interest in any other manner obstruct or interfere with the use of such rights-of-way and easements, except for the following: (a) that certain "East Gate" intended to be located on Keetley Road in the vicinity of Jordanelle Village; (b) that certain "West Gate" intended to be located on Keetley Road in the vicinity of McKinley Gap or Queen Esther Drive; and (c) speed bumps as may be required by an Association.
- 4.2. <u>Emergency Crash Gates</u>. Notwithstanding the provisions of Paragraph 4.1, (a) DCA shall be entitled to close a portion of Keetley No. 4 (as described on the attached <u>Exhibit</u> <u>F</u>) to allow only emergency vehicle access through crash gates, as may be required by the governmental agency with jurisdiction or the applicable Sub-Association, and (b) Trans-Wasatch shall

be entitled to close a portion of Hidden Hollow No. 2 (as described on the attached Exhibit F) to allow only emergency vehicle access through crash gates, as may be required by the governmental agency with jurisdiction or the applicable Sub-Association.

- 5. Assignment to Association. It is contemplated that the Owners of the various portions of the Parcels will form Sub-Associations with respect to each such portion, and that such Sub-Associations will be members of the Master Association. Once a Sub-Association with respect to any such portion is formed, each Owner that is a member of such Sub-Association shall convey and assign all of such Owner's rights, benefits and obligations under this Declaration with respect to such portion, and such Sub-Association shall accept such conveyance and assignment and assume and agree to perform and be bound by such rights, benefits and obligations. Concurrently with such conveyance, assignment, assumption and agreement, or with a conveyance, assignment, assumption and agreement made directly between one or more Owners and the Master Association without a Sub-Association being formed with respect to the portion of the Parcels owned by such Owners (each, a "Transfer"):
- (a) all rights and benefits of the assigning Owners under this Declaration shall be exercised on and after the date of such Transfer exclusively by such Association and not by such assigning Owners (except through such Association as members of such Association);
- (b) the assigning Owners shall be released from all obligations under this Declaration for the period on and after the date of such Transfer; and
- (c) such Association shall be responsible for all obligations under this Declaration with respect to the portion of the Parcels concerned for the period on and after the date of such Transfer.

- 6. <u>Duration</u>. This Declaration and each right-of-way, easement, covenant and restriction set forth in this Declaration shall be perpetual, except with respect to right-of-way and right set forth in Paragraph 2.3, which shall be limited by the terms and conditions of the BLM Permit.
- 7. Not a Public Dedication. Nothing contained in this Declaration shall be deemed to be a gift or dedication of all or any portion of the Parcels for the general public or for any public purpose whatsoever, it being the intention of Trans-Wasatch and DCA that this Declaration be strictly limited to the purposes expressed in this Declaration.
 - 8. Appurtenances to Parcels; Covenants Run with Land; Various Events.
- 8.1. Appurtenances to Parcels. Except in connection with the creation of an Association or a dedication made to the public, each right-of-way, easement, covenant and restriction created by this Declaration is an appurtenance to the Parcel benefited by such right-of-way, easement, covenant and restriction (but no other real property) and may not be transferred, assigned or encumbered except as an appurtenance to the benefitted Parcel.

8.2. Covenants Run with Land; Various Events.

- 8.2.1. Covenants Run with Land. Each right-of-way, easement, covenant and restriction contained in this Declaration (whether affirmative or negative in nature) shall (a) create an equitable servitude on the burdened Parcel in favor of the benefitted Parcel (but no other real property), (b) constitute a covenant running with the land, and (c) benefit and bind each Party in Interest with respect to the portion of the Parcel concerned to the extent that such portion is affected or bound by the right-of-way, easement, covenant or restriction in question, or to the extent that such right-of-way, easement, covenant or restriction is to be performed on such portion.
- 8.2.2. <u>Transfer of Property</u>. If any Owner transfers all or any portion of the Parcel owned by such Owner, such transferring Owner shall be released and discharged from all obligations under this Declaration that accrue after the date of recordation in the official records of the instrument effecting such transfer.
- 8.2.3. Effect of Breach. No breach of this Declaration shall entitle any Party in Interest to cancel, rescind or otherwise terminate this Declaration (but such limitation shall not affect any other right or remedy or limit any obligation that any Party in Interest may have under this Declaration by reason of any such breach), or defeat or render invalid the lien of any Mortgage made in good faith and for value as to any Parcel, except as provided in Paragraph 9.
- 8.2.4. <u>Identical Ownership</u>. The ownership of one or more Parcels by the same person shall not result in the termination of this Declaration.
- 8.2.5. Priority of Declaration. The interests in and rights concerning any portion of the Parcels held by or vested in Trans-Wasatch and DCA or any other person on or after the date of this Declaration shall be subject and subordinate to the arrangement provided for in this Declaration, and the arrangement provided for in this Declaration shall be prior and superior to such interests and rights, as may be necessary to effectuate all of the terms and provisions set forth in this Declaration.
- Lien. Following the formation of a Sub-Association with responsibility for 9. maintenance of any portion of the Roadways, if the failure to timely pay any sum when due under this Declaration which relates to such portion is not cured within thirty (30) days after written notice is given by such Sub-Association to a defaulting Owner, such sum and any subsequent delinquencies may be secured by a lien against the defaulting Owner's lot. Such lien shall be evidenced by a notice of lien filed for record by such Sub-Association in the official records. A copy of such notice of lien shall be given by such Sub-Association to the defaulting Owner within ten (10) days following recordation in the official records. Such notice of lien shall set forth the unpaid amount, the date such amount was due and a description of the property subject to such lien, and shall be signed by such Sub-Association. Any such lien may be foreclosed in the same manner as is provided under applicable law for the foreclosure of Mortgages, but shall be subject and subordinate to (a) each Mortgage affecting the defaulting Owner's Parcel at the time such notice of lien is recorded, (b) this Declaration, (c) each (recorded or unrecorded) utility easement, right-of-way or similar interest affecting the defaulting Owner's Parcel at the time such notice of lien is recorded, (d) the interest of the tenant or lessee under each lease, rental agreement or similar instrument (whether recorded or unrecorded) affecting the defaulting Owner's Parcel at the time such notice of lien is recorded,

and (e) the lien for general taxes and other governmental assessments, but shall be prior and superior to all other interests or estates (whether recorded or unrecorded at the time such notice of lien is recorded) in or respecting the defaulting Owner's Parcel.

10. Compliance with Other Declarations. Once such Association is formed, the Hidden Hollow Parcel will be a part of the Snowtop Homeowners Association, the Sub-Association for the Snowtop Property, and any other Association in which the Snowtop Property lot owners are members, including, but not limited to, the Master Association. The Owners of any portion of the Hidden Hollow Parcel shall comply with any declaration of covenants, conditions and restrictions of the Master Association and any other declaration of covenants, conditions and restrictions applicable to the Hidden Hollow Parcel. The Owner of any portion of the Hidden Hollow Parcel shall be a member (either directly or, as is anticipated, indirectly through a Sub-Association) of the Master Association and any other Association relating to the Hidden Hollow Parcel and shall share on a pro rata basis in the assessments and common expense of such Associations applicable to such property. It is contemplated that the Snowtop Homeowners Association will be formed, and all relevant covenants, conditions and restrictions and other documents will be prepared, by DCA.

11. Modification; Dedication of Certain Portions of Roadways.

- 11.1. Modification. Except as set forth in Paragraphs 11.3 and 11.4, this Declaration and any right-of-way, easement, covenant or restriction contained in this Declaration may not be terminated, extended, modified or amended without the consent of each Party in Interest and any such termination, extension, modification or amendment shall be effective on recordation in the official records of a written document effecting the same, executed and acknowledged by each Party in Interest; provided, however, that except as provided in Paragraphs 11.3 and 11.4, no such termination, extension, modification or amendment shall affect the rights of any Mortgagee holding a Mortgage constituting a lien on any Parcel unless such Mortgagee consents to the same in writing.
- 11.2. Reconfiguration of Roadways. During the course of planning and development of the Parcels, the location and configuration of the Roadways may change, and such change may require the modification or amendment of this Declaration and/or the applicable governmental authorizations and approvals. Accordingly, on the written request of the Owner of the portion of the Roadways concerned, all Parties in Interest shall execute and deliver any reasonably required modifications or amendments to this Declaration and/or the applicable governmental authorizations or approvals and, at the sole cost and expense of such Owner, take such further actions as may be reasonably requested by such Owner in connection with obtaining the applicable governmental authorizations and approvals.
- planning and development of the Parcels, the portion of the Roadways located within the Jordanelle Parcel may, as determined at the sole discretion of the Jordanelle Parcel Owner, become dedicated as a public road, and such planning, development and dedication, as applicable, may require the modification or amendment of this Declaration and/or the applicable governmental authorizations or approvals. Accordingly, on the written request of the Jordanelle Parcel Owner, all Parties in Interest shall execute and deliver any reasonably required modifications or amendments to this Declaration and the applicable governmental authorizations or approvals and, at the sole cost and expense of the Jordanelle Parcel Owner, take such further actions as may be reasonably requested

by the Jordanelle Parcel Owner in connection with accomplishing such dedication and in obtaining the applicable governmental authorizations and approvals. Notwithstanding the provisions of Paragraph 3, concurrently with such dedication, the maintenance obligations with respect to such dedicated portion of the Roadways shall be transferred to and shall be assumed by the governmental entity to which such dedication is made, and the Parties in Interest having such obligations prior to such dedication shall be released from such obligations.

- 11.4. <u>Dedication of Slalom Village Bypass Road</u>. The Slalom Village Bypass Road Owner may, without the prior consent or approval of any other Party in Interest, Mortgagee or other person, transfer the Slalom Village Bypass Road to Park City Municipal Corporation.
- 12. Attorneys' Fees. If any Party in Interest brings suit to enforce or interpret this Declaration or for damages on account of the breach of any provision of this Declaration, the prevailing party shall be entitled to recover from the other party its reasonable attorneys' fees and costs incurred in any such action or in any appeal from such action, in addition to the other relief to which the prevailing party is entitled.
- 13. <u>Notices</u>. Any notice or demand to be given by one party to the other shall be given in writing by personal service, telecopy, express mail, Federal Express, DHL or any other similar form of courier or delivery service, or mailing in the United States mail, postage prepaid, certified and return receipt requested, and addressed to such party as follows:

Whenever possible, each provision of this Declaration shall be interpreted in such manner as to be valid under applicable law; but, if any provision of this Declaration shall be invalid or prohibited under applicable law, such provision shall be ineffective to the extent of such invalidity or prohibition without invalidating the remainder of such provision or the remaining provisions of this Declaration. Each exhibit referred to in, and attached to, this Declaration is an integral part of this Declaration and is incorporated in this Declaration by this reference.

DECLARATION OF EASEMENTS, COVENANTS AND RESTRICTIONS

BLM LAND

The BLM Land referred to in the foregoing Declaration is located in Summit County, Utah, and is described as follows:
