And Whereas, the said Cedar Mercantile & Live Stock Company, A Corporation has paid for said lands, pursuant to the conditions of said sale, and the laws of the State duly enacted in relation thereto, the sum of Fifteen Hundred and no/100 (\$1500.00) Dollars, and all legal interest thereon accrued, as fully appears by the certificate of the proper officer, now on file in the office of the Secretary of State of the State of Utah;

Now Therefore, I, Simon Bamberger, Governor, in consideration of the premises, and by virtue of the power and authority vested in me by the laws of the State of Utah, in such case made and provided, do issue this Patent, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said Cedar Mercantile & Live Stock Company, A Corporation its successors and assigns forever, the following piece or parcel of land, situate in the County of Washington, State aforesaid, to wit:

The East Half (E) of the Northwest quarter (NW $\frac{1}{4}$), and the East Half (E) of the Southwest quarter (SW $\frac{1}{4}$) of Section Twenty-two (22); the Northwest quarter (NW $\frac{1}{4}$) of the Southeast quarter (SE $\frac{1}{4}$); the North Half (N $\frac{1}{2}$) of the Northwest quarter (NW $\frac{1}{4}$); the Southwest quarter (SW $\frac{1}{4}$) of the Northwest quarter (NW $\frac{1}{4}$), and the Southwest
