RIGHT OF WAY DEED.

Josephine C. N. Burrows, single grantor of Huntsville County of Weber State of Utah, hereby grants, bargains and sells to the STATE OF UTAH, WEBER COUNTY, Grantee, for the sum of ONE THOUSAND ONE HUNDRED TWENTY-EIGHT & 00/100 DOLLARS, the following described right of way across the grantor's land in Weber County, State of Utah, as follows:

Right of way for highway known as WPSO Project No. 193 across the grantor's land in the W₂ of W₁ of Section 6, T 6 N, R 2 E, S. L. B & M. Said right of way is a strip of land of the

following widths on the east side of the center line of survey of said project. 40 ft. in width between Engineer's Station 114/91.5 & 122/00; 90 ft. in width between Engineer's Stations 122/00 & 125/00, & 40 ft. in width between Engineer's Stations 125/00 & 151/57.0, and on the west side of said center line extends to the west line of said Section 6. Said center line is described as follows:

Beginning at the intersection of the north boundary line of said grantors' land and said center line of survey at Engineer's Station 114/91.5, which point is 1328.9 ft. southerly along the west line of said Section 6 and 49.3 ft. east along the north line of said grantors' land from the northwest corner of said Section 6; thence S. 0°30' W., 1125.1 ft.; thence S. 0°57' W., 1157.0 ft.; thence S. 0°32' W., 1383.4 ft. to the intersection of said center line of survey at Engineer's Station 151/57.0 and a southerly boundary line of said grantors' land, which point is 331.9 ft. northerly along the west line of said Section 6 and 49.6 ft. east from the southwest corner of said Section 6, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains 7.52 acres.

As part of the consideration for the above described highway right of way, the grantor hereby grants to the State Road Commission of Utah permission to relocate and reconstruct within the grantor's land and outside the limits of above described right of way all irrigation ditches made necessary by the construction of said project.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
