

FIRST AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS
AND RESTRICTIONS AND RESERVATIONS OF EASEMENTS FOR CROWN
POINTE, A PLANNED RESIDENTIAL UNIT DEVELOPMENT

This First Amendment to The Declaration of Covenants Conditions and
Restrictions and Reservations of Easements for Crown Pointe A Planned Residential Unit
Development("Declaration") having been approved by the members of the Crown Pointe
Owners' Association, Inc.. ("Association") at a duly called and noticed meeting of the
Association held on September 18, 2003 is dated this 18th day of September, 2003.

WHEREAS, it is the desire of the members of the Association to remove from the
Duties and Powers of the Association any responsibility for maintenance and/or repair of
air conditioning systems and equipment whether or not located on the Common Area;
and

WHEREAS, control of the Association is vested in the members of the
Association.

NOW THEREFORE, the members of the Association amend the Declaration as
follows:

1. Article I Definitions Section 18 is deleted and replaced by the following:

Section 18. "Improvement" shall mean all structures and appurtenances of
every type and kind, including but not limited to buildings, out buildings,
walkways, sprinkler pipes, carports, roads, driveways, parking areas, fences,
screening walls, retaining walls, stairs, decks, landscaping, hedges,
windbreaks, plantings, planting trees and shrubs, poles, signs, and water
softener fixtures or equipment.

2. Article V Duties and Powers of the Association Paragraph (a) is deleted and
replaced by the following:

(a) Maintain, repair and otherwise manage the Common Area and all
facilities, improvements (excluding air conditioning equipment) and
landscaping thereon in accordance with Article VI of this Declaration.
