Grantor, hereby GRANTS and CONVEYS to PROVO CITY CORPORATION, at  
351 West Center, Provo, Utah 84601, Grantee, for the sum  
of TEN Dollars,

a perpetual easement, upon part of an entire tract of property in the projected  
NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 13, T.7S., R.2E., SLB&M, in Utah County, Utah, for the purpose of  
constructing thereon a drainage line, and appurtenant parts thereof, to facilitate  
the construction of an expressway known as Project No. 15-6.

The boundaries of said part of an entire tract are described as follows:

Beginning at a point in the southerly boundary line of a wetland mitigation  
site and detention pond of said project, which point is 48.432 meters west and  
1135.052 meters south from the Northeast corner of said Section 13; thence  
S. 89°38'00" E. 18.177 meters along said southerly boundary line; thence  
S. 56°15'22" E. 32.350 meters; thence S. 33°44'38" W. 10.000 meters; thence  
N. 56°15'22" W. 47.529 meters to the point of beginning.

The above described part of an entire tract contains 399 square meters in  
area.
