of TEN Dollars,

a perpetual easement, upon part of an entire tract of property in the projected  
SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 18, T.7S., R.3E., SLB&M, in Utah County, Utah, for the purpose of  
constructing and maintaining thereon a drainage pipe and appurtenant parts thereof,  
to facilitate the construction of an expressway known as Project No. 15-6.

The boundaries of said part of an entire tract are described as follows:

Beginning at a point in the northeasterly right of way and N/A line of  
expressway I-15 Project No. 15-6, which point is 1416.083 meters south and 34.144  
meters east from the Northwest corner of said Section 18, at a point 42.211 meters  
perpendicularly distant northeasterly from the center line of said I-15 opposite  
Engineer Station 3+058.469; thence S. 31°45'27" E. 92.959 meters along said right  
of way and N/A line; thence N. 47°51'28" E. 16.756 meters; thence N. 42°08'32" W.  
91.436 meters to the point of beginning.

The above described part of an entire tract contains 766 square meters in  
area.
