WHEREAS, SIENNA HEIGHTS, LLC, a Utah Limited Liability Company, 90 South 400 West, Suite 300, Salt Lake City, Utah 84101, heretofore purchased from the State of Utah, the lands hereinafter described, pursuant to the laws of said State,

AND WHEREAS, the said SIENNA HEIGHTS, LLC, a Utah Limited Liability Company, has paid for said lands, pursuant to the conditions of said sale, and the laws of the State duly enacted in relation thereto, the amount of Two Million Four Hundred Twenty Eight Thousand Nine Hundred Eighty Seven Dollars and No Cents (\$2,428,987.00), and all legal interest thereon accrued, as fully appears by the certificate of sale;

NOW THEREFORE I, JON M. HUNTSMAN, JR., Governor, by virtue of the power and authority vested in me by the laws of the State of Utah, do issue this PATENT, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said SIENNA HEIGHTS, LLC, a Utah Limited Liability Company, and to its successors and assigns, the following tracts or parcels of land, situated in the County of Washington, State of Utah, to-wit:

Township 42 South, Range 15 West, SLB&M Sections 12 & 13: within, more particularly described as follows:

TO HAVE AND TO HOLD the above described and granted premises unto the said SIENNA HEIGHTS, LLC, a Utah Limited Liability Company, and to its successors and assigns forever;

Excepting and reserving to the State of Utah all coal, oil and gas, and other mineral deposits, along with the right for the State or other authorized persons to prospect for, mine, and remove the deposits; also,

Excepting and reserving to the State of Utah, School and Institutional Trust Lands Administration, its successors in interest, assigns, permittees, licensees and lessees, a perpetual easement across, over and through the granted premises, appurtenant to and benefiting property owned by the State of Utah, as may be necessary and reasonable to locate, install, operate and maintain a fiber optic system and related facilities and other equipment in connection therewith; also,

Excepting and reserving to the State an easement across the Property for the benefit of the State and the Trust Lands Administration, their respective successors in interest, assigns, permittees, licensees and lessees, as may be necessary and reasonable to install and maintain an entry feature along the southwestern boundary of Parcel 11B, as shown on the diagram attached as **Exhibit A**; also,

Excepting and reserving to the State of Utah, School and Institutional Trust Lands Administration, its successors in interest, assigns, permittees and lessees, a perpetual easement across the property to other lands owned by the State of Utah, for the following purposes:

For ingress and egress of pedestrians, equestrians, vehicles and equipment and of all invitees, permittees, assignees and successors in interest of the School and Institutional Trust Lands Administration, and for all other lawful purposes except for public use or public access, together with the right to repair, maintain, inspect, grade and improve the right-of-way and easement from time to time; and

For construction, placement and installation of utilities (to include lines, apparatus and facilities for electric power, natural gas, culinary water, irrigation water, sanitary sewer, telephone, cable, and other electronic transmission) as may become necessary and the right to repair, maintain, inspect, alter, enlarge, relocate and replace the same from time to time within and along the right-of-way and easement area.

Provided, however, that the above described easements, to the extent they are blanket in nature, may be modified and amended from time to time at the School and Institutional Trust Lands Administration's option, such that the easements would be specifically identified and located.

Subject to any valid, existing rights of way of any kind and any right, interest, reservation or exception appearing of record, including, without limitation, that certain Declaration of Covenants, Conditions, Restrictions and Easements for Sienna Hills; that certain Development Agreement between the School and Institutional Trust Lands Administration and the City of Washington to be recorded against the property prior to the date of any conveyance to the Purchaser; and that Declaration of Development Covenants applicable to the granted premises as recorded with the Washington County Recorder, and subject also to the permitted exceptions listed on any title insurance policy issued in connection with this transaction and all rights of way for ditches, tunnels, and telephone and transmission lines that have been or may be constructed by the United States as provided by statute.


