Private Ingress and Egress Easement

Recitals:

1. Ledges Partners, LLC, a Utah Limited Liability Company (hereinafter "Ledges Partners") is the owner of that certain property more fully identified on Exhibit "A" attached hereto and made a part hereof.
2. On March 8, 2006, Ledges Partners, as owner, recorded, as Entry No. 20060007007, the Official Plat of the Ledges of St. George - Phase 2, a subdivision located in the Washington County, State of Utah.
3. On March 8, 2006, Ledges Partners, as owner, recorded, as Entry No. 20060007011, the Official Plat of the Ledges of St. George - Phase 4, a subdivision located in the Washington County, State of Utah.
4. On April 25, 2006, Ledges Partners, as owner, recorded, as Entry No. 20060016178, the Official Plat of the Ledges of St. George - Phase 5, a subdivision located in the Washington County, State of Utah.
5. Access to the above 3 subdivisions is provided over and across the property identified in Exhibit "A" referenced above.
6. Ledges Partners desire to establish a private easement for ingress and egress for the owners of lots within the above described subdivision, and any future subdivision filed by Ledges Partners, and/or its successors in interest, which lies adjacent to the herein described easement.

Now therefore, Ledges Partners, does hereby grant a private easement for ingress and egress to the lot owners within the above described subdivisions over and across the property more fully identified on exhibit "A" identified herein. Said easement is not for the use of the general public and shall be appurtenant to and run with each lot within the above described subdivisions. Said easement shall automatically expire upon the recording of a private road dedication that would provide access to the subdivisions herein.




